Phase 5 Annexation Areas 6 and 7 - FIF Waiver Extension Ends December 31, 2011

This is a reminder that the Facility Investment Fee (FIF) waiver associated with connecting to the newly installed sewer services in your area ends on December 30, 2011. In May, the Public Works Commission authorized an extension of the original FIF waiver because of storm damage in the area (see Figure 1).

While the extension period ends on December 30th, we realize there are residents still recovering from the April storms. If you want to connect to sewer but are unable to do so before the waiver expires, please contact us at 910-223-4600 to discuss available options.

<i>Phase 5 Annexation Areas 6 and 7 FIF Waiver Extension</i>		
<p>This letter is a follow up to correspondence regarding connection of your property to the PWC utility system. As previously stated, the facility investment fee (FIF) of \$640 would be waived if connection was made within six months of being notified sewer was available. Due to the recent weather event in this area, the Public Works Commission has authorized an extension of the FIF waiver period. If you connect to the sewer service by Friday, December 30, 2011, the FIF will be waived.</p> <p>As a reminder, the City of Fayetteville offers financial assistance to income-eligible homeowners to assist with both the plumber charges and the assessment. To determine if you qualify, please contact Barbara Little, City of Fayetteville Community Development Administrator, at 433-1598 prior to hiring a plumber or connecting to the lines.</p> <p>The City of Fayetteville and PWC sincerely appreciate your cooperation throughout the utility improvement project.
