



NON-RESIDENTIAL SANITARY SEWER SERVICE-OUTSIDE CITY

(This schedule applies to Rate Code WW-NRES; WWO-NRES;SWW-NRES,SWWO-NRES)

AVAILABILITY Available throughout the territory served by the Public Works Commission, outside the limits of the City of Fayetteville, in accordance with the Commission's established Service Regulations and Charges.

APPLICABILITY Applies to non-residential or industrial sanitary sewer service where the customer is billed monthly for PWC metered water service and where all wastewater is discharged into the sanitary sewer system at a single discharge point.

CHARACTER OF SERVICE Wastewater shall be collected and treated in accordance with the Sanitary Sewer Use Ordinance of the City of Fayetteville.

MONTHLY RATE The monthly rate shall be the sum of the Usage Charge, the Basic Facilities Charge, and the Sanitary Sewer Surcharge (where applicable).
