## I. REGULAR BUSINESS

Prior to the official start of the meeting, Chairwoman Shaw presented to Mr. David W. Trego a Certificate of Achievement for 10 years of service to PWC.

Chairwoman Evelyn Shaw called the meeting of Wednesday, August 12, 2020, to order. Considering this is a remote, video-conference meeting, a roll-call of Commissioners was taken. The following Commissioners confirmed their attendance: Evelyn O. Shaw, D. Ralph Huff, and Darsweil L. Rogers.

#### APPROVAL OF AGENDA

Mr. Trego requested for an item to be added to the agenda as Item IV, entitled "Discuss Request for Easement for Property Under PWC's Management and Control to Duke Energy", and all subsequent items moved down. Commissioner Rogers motioned to amend the agenda as requested, Commissioner Huff seconded, and the motion was unanimously approved. (Commissioners Rogers, Huff and Shaw-3Aye, 0-Nay).

Commissioner Huff motioned to approve the amended agenda. Commissioner Rogers seconded and it was unanimously approved. (Commissioners Rogers, Huff and Shaw-3-Aye, 0-Nay).

#### II. CONSENT ITEMS

Upon motion by Commissioner Rogers, seconded by Commissioner Huff, Consent Items were unanimously approved. (Commissioners Rogers, Huff and Shaw, 3-Aye, 0-Nay).

The Proposed Resolution # PWC2020.10 Authorizes PWC to officially designate Ike Copeland, Director of Legal, Risk and Procurement Services and Ray Jackson, Environmental Compliance and Emergency Management Manager as the PWC Applicant Agents for COVID-19 (declaration FEMA 4487 DR-NC). This authorization allows each designated Agent to file, request, and authorize acceptance of financial assistance from FEMA for damages related to COVID19 on behalf of PWC. This request is required in order for FEMA to issue reimbursements to PWC for qualifying damages.

F. Approve bid recommendation to award bid for purchase of one (1) 35,000 GVWR Cab and Chassis with Asphalt Body to White's International, Greensboro, NC, the lowest responsive, responsible bidder in the total amount of \$173,594.41, and forward to City Council for approval.

The 35,000 GVWR Cab and Chassis with Asphalt Body is budgeted in FY2021 Operating Capital Budget (Budget code 2106202569) in the amount of \$210,000.00.

BASIS of AWARD: The lowest bidder Thermo-Lay didn't mark any exceptions or variances to the bid, although they are using the same chassis the other vendors are quoting, and those bids noted variances. Thermo-Lay provided two references, one at Clemson University and the other at City of Suffolk. The contact at Clemson provided positive feedback for their machine, however they only have one unit that is a year old and is used sparingly, not to mention this is the first and only patch truck they have ever owned. The contact at the City of Suffolk has not answered or returned reference check calls. The City of Suffolk did not provide any feedback and per Thermo-Lay they are the largest user of their product. The bid state: "Failure to clearly identify all exceptions or variations as determined by and at the discretion of the Public Works Commission, may be cause for rejection of the bid". Considering the fact that variances were not identified in the Thermo-Lay bid and the lack of a sufficient number of references to verify performance of Thermo-Lay's equipment, we request this bid be rejected, and award is recommended to White's International, Greensboro, NC, as the lowest responsive and responsible bid.

**COMMENTS:** Notice of bid was advertised through our normal channels on June 19, 2020, with a bid opening date of July 16, 2020. Bids were solicited from twelve (12) vendors with three (3) vendors responding. **SDBE/Local Participation**: White's Int'l, Greensboro, NC, is not a local business that is not classified as a SDBE, Minority or Woman-Owned business.

G. Staff requests the Commission approve the issuance of a purchase order in the amount of \$90,434.00 to MinsaitACS, Norcross, GA, for the purchase of an upgrade of our current electric substation supervisory control and data acquisition (SCADA) that is running on PRISM 10 to the newest release of the core software, PRISM 11, and to enter into an agreement to purchase a four year long term service agreement. Purchase of this upgrade and support is in accordance with N.C.G.S. 143-129(e)(6), commonly known as the "sole source" bidding exception.

COMMENTS: N.C.G.S. 143-129(e)(6) allows an exception to the bidding requirements for the purchase of apparatus, supplies, materials or equipment when a needed product is available from only one source of supply. PRISM is a SCADA software platform written, sold and distributed exclusively by Minsait-ACS, an Indra Company. Minsait-ACS maintains all copyright privileges for their products and these products must be purchased directly from the company. There are no agents or dealers authorized to resale these products. This upgrade provides significant improvements over the existing software such as increased system performance including the ability to process ten times more database changes/sec than prior version along with enhanced alarm/event functionality and security features. SCADA software is a niche market and very specific along with being highly regulated. There are no options to get an upgrade package from different vendors for this particular SCADA software. To be in compliance with both federal and state regulations, this SCADA software needs to be kept up to date, otherwise risk possible violation of regulations as well as increased system vulnerability risk.

This is a budgeted item. \$90,434.00 is budgeted in SCADA Upgrade (001.0821.0802..397000.2108212542). The annual amount of \$61,219, for the long term service agreement will be budgeted in the appropriate out-year budgets.

## III. UPDATE ON DEVELOPMENT OF AN ASSET PROTECTION PROGRAM Presented by: Marc Tunstall, Electric Operations Manager

Mr. Trego stated we will discuss maintaining the integrity of private easements PWC has obtained over the years for our electric as well as water systems. He stated this issue has been growing over the years, and although we have very robust electric and water systems, it has not caused a lot of conflicts, but this is something we need to address. Mr. Trego defined the difference between asset management and asset protection. Mr. Trego then introduced Marc Tunstall, PWC Electric Operations Manager.

Mr. Tunstall stated this presentation is for informational purposes only. He stated a team was developed to help protect our electrical assets. He stated our lead consultant is Norwood West, a former Duke Energy Asset Protection Specialist. Anthony Roper and Carlton Jackson of CP Engineering are our technical consultants. CP Engineering is an engineering firm that utilized drones to produce survey grade videos of our assets and encroachments of PWC's right-of-way (ROW). Mr. Rynne stated that is something we were never able to do before.

Mr. Tunstall stated asset protection for the transmission/distribution system is about protecting our right-of-way easements. We must be able to protect our easements in order to protect our assets so we can service them on blue sky days and utilize them on dark sky days during hurricanes and natural disasters.

He stated the team began the evaluation on the electric side and plan to move on to the water side. They plan to begin with the 230kV circuits and work down to the sub-transmission, distribution, wastewater and water systems. He stated they will begin at the transmission level because the 230kV has between 28,000 to 35,000 customers connected; the 69kV circuits have between 7,000 -10,000 customers connected and; the distribution circuits have 1,000 to 2,000 customers connected.

Commissioner Rogers asked if there is a reason why you can't complete electric, water and wastewater at the same time. Mr. Trego responded we are using a drone to go over our ROW and they are not in the same place.

Mr. Tunstall stated PWC's transmission/distribution system is \$203M. We have 804 miles of overhead conductor and 648 miles of underground cable. PWC's position is rooted in underlying easement law. He stated it should be noted that NC courts are very protective of electrical transmission line easements. He noted several court cases which upheld utility easement rights.

The Duke Energy Carolinas, LLC vs Gray et al upheld the utility's rights and provided a statute of limitations for 20 years relative to legal action. Mr. Trego stated if there is an encroachment on one of our right of ways and we do not act in 20 years we lose some of our rights after the 20 year period.

Mr. Tunstall stated an encroachment is "buildings or improvements that intrude or trespass upon the property or right of way of another". He stated these encroachments cause issues for our asset ROW activities and cause problems during outages.

Mr. Trego stated part of the issue for PWC is there may be a number of property owners who may have granted us the easement and may have forgotten. Also, we have 20% customer turnover here a year, and NC law does not require mandatory disclosure of easements when the property is purchased. So, someone may buy property and the new owner may not know there is an easement on the property, and they think they can build. Commissioner Huff stated in previous years, every transaction had to have a new survey. But it was stopped 7-8 years ago, and people are buying property and do not know there is an easement on it. Discussion ensued.

#### PWC Asset Protection Plan Overview

Mr. Tunstall stated the plan consists of four phases. The explanation of Phase 1 will be expanded on in the presentation today.

- Phase 1: Define the extent of encroachments
- Phase 2: Determine Priorities
- Phase 3: Plan Implementation
- Phase 4: Proactive Asset Management

Mr. Tunstall stated utilities (by large) patrol their 230 and transmission lines by helicopter. Generally, they patrol their lower voltage lines by foot. However, with advances in drone technology we can patrol our distribution and sub-transmission right-of-way (ROW) with drone technology. We used this technology in the pilot project and integrated it with site survey grade references to produce survey grade video of the area we patrol. He stated this is very efficient use of current technology. Mr. Trego stated the accuracy is within a foot, so it is very accurate.

Mr. Tunstall displayed a side by side picture of the State Ortho which is produced every four years and the SEPI Drone Ortho, (high resolution photo) which showed apparent differences in the technology.

Commissioner Shaw stated she is curious if the City's UDO dovetails with PWC's easements. Mr. Trego stated he does not believe so because there are so many easements out there (PWC, DOT, Lumbee and South River). He stated if anything it is just a general mention in the UDO because the

terms can be different for the individual right-of-way (ROW). Discussion ensued involving possible options.

Discussion began regarding interaction with the customers when addressing encroachment issues. Commissioner Shaw stated she understands we are talking going forward by educating the customers, yet, she still has a concern that the citizen is receiving the short end of the stick because of the lack of knowledge. She noted the sample that was displayed, and it would be multiplied many times over

among the customer base. Mr. Trego stated though we have many private easements among the 66kV system. Most of them are adjacent to a road. He would not say it is a huge, but it is an issue we need to deal with.

Mr. Trego stated there are more possible issues because of the way sewer flows in the Water Resources Division. He stated we must go behind homes more often with the sewer, depending on the way properties are laid out. He stated the issues Mr. Noland must deal with pertaining to access is slightly different, and the risk is different, but it is still an issue regarding the integrity of the easements.

Mr. Noland stated since we are doing retrofitting for annexation, and we are placing sewer lines in backyards and not in streets. The issue is elevated with citizens placing fences and sheds and planting trees and there is a sewer line there and they are not aware there is an easement there.

Mr. Tunstall stated PWC plans to move from a reactive posture to a proactive posture. He stated in order to do so he assumes we need to meet with realtors, developers and others to ensure they understand we have easements crossing their properties.

Develop PWC Policies & Guidelines - We will work with our lead consultant Norwood West to
help develop policies and guidelines; and with our technical consultant CP Engineering to continue
the drone flyovers to determine the extent of our encroachments.
Complete Phase 1
Evaluate Financial & Customer Impact

Additional discussion ensued regarding the selection of the consultants.

Mr. Trego stated this is not the last time we speak to the Commissioners regarding this issue. It obviously has some policy implications, and a customer service implication. We wanted to let you know what we found and the issues that are there, so once we are in Phase 1 and we do the assessment we can come back to the Commissioners with a more robust idea of where we are so we can get direction from the Commission. Obviously, this is something we will deal with homeowners with.

Commissioners Rogers stated he has a multiphase view of how this should go. He believes we need to request for the legislation to be changed; there needs to be conversations with the municipal from legal point of view. We need to request for the NC Realtors to change their policies; whenever we

turn on a customer, we need to have something in their paperwork to let them know there may be an encroachment or easement. Additional discussion ensued.

Mr. Trego stated we will forward with Phase I for the electric and then for the water and sewer.

## IV. DISCUSS REQUEST FOR EASEMENT FOR PROPERTY UNDER PWC'S MANAGEMENT AND CONTROL TO DUKE ENERGY – *ADDED ITEM*

Mr. Trego stated during the last Commission meeting the Commissioners approved a resolution to grant authority to the CEO/GM to approve easements when DOT, another utility, basically anyone who has condemnation rights comes to us and requests an easement. That item was sent to City Council for approval, but it was pulled from the agenda.

We have an easement we need to have executed from Duke Energy Progress on a property so they can serve our facility. Not knowing if the City Council will take up the resolution later, he needs to have this issue addressed. Mr. Trego stated the Commissioners have before them the easement; a drawing of the Duke Energy easement serving our booster pump station. Mr. Trego requests for the Commission to approve PWC issuing the easement to Duke; authorize staff to forward the easement to City Council; upon their approval, authorize the PWC CEO/GM to sign the easement so we can get service to our booster station.

Commissioner Rogers motioned to approve the easement as presented, motion was seconded by Commissioner Huff and unanimously approved. (3-Aye, 0-Nay)

#### IV. GENERAL MANAGER REPORT

Attorney General is looking at addressing the sources of contamination in our water. This is something Mr. Noland and PWC have been very proactive in promoting. We believe, rather than treating water it is better to eliminate it at the source. We do not have details on what the Attorney General will do. Yet we are encouraged they will look at the sources of this and try to curb it for the wellbeing of the citizens and the water.

#### COVID-19

The Governor extended Phase II an additional period of time. We are continuing to operate as we are. We still have employees WFH and Reporting from Home. Our Customer Service building is not open. We are limiting visitors to our building. We will continue. When the Governor goes into Phase III, we will reassess and see what we need to do. But as of now we are on hold.

Effective July 31<sup>st</sup>, Executive Orders 124 and 142 went into the next phase, where the moratorium on disconnections for non-payment of bills ended. We are now into the period where we have to give customers a minimal of six months to pay. He reminded the commissioners they authorized him via directives to make temporary changes to our service regulations and policies on a temporary basis so we can comply with the EO. Mr. Trego stated he has done so, and they are on our website. We have gone through a number of reviews with Jamie West. Jamie has had interactions with the AG, and they are aware of what we are doing. We asked for clarification on issues, so we comply with not only the letter of the EO, but also on the intent of the EO. We put out the directives, and they can change if the situation changes. The bills began going out on Monday. The bills have the 1/6 amount as well as

their regular bill. They are instructed if they have difficulties to call in to our Customer Service if they need additional assistance. We also encourage customers to call in if they need additional assistance.

We just had our kick-off on our first major upgrade of our Oracle System since it was implemented, we will upgrade on CC&B. We are in a major upgrade. It is an over year project. We just had the kick-off the other day. A lot of it is behind the scenes. It is a technical upgrade. The new system has enhancements It combines some operations into one format. We have a very good employee team working with our consultant. We will bring updates as we go along. It is part of our roadmap to ensure we are upgraded.

#### V. COMMISSIONER/LIAISON COMMENTS

#### **Commissioner Rogers**

He stated he has had a number of clients that he suggested that they just take the temperature of their workforce "How are you doing". He stated the outflow of emotion has been quite intense. People are feeling all sorts of concern and worry. Job performances are being impact and he does not feel that people are fully understanding or appreciating how this whole thing is playing on them. He encourages as employers we have the conversation. Suddenly you begin to really understand and appreciate the impacts. It is not just for those with kids, but also for those with elderly parents. We are all just dealing with this. To the extent you ask the question and begin to manage through how people are dealing, he believes is a smart move.

#### Council Member Davis

His observation is with the conversation we are having regarding easements. He looks forward to finding a way to work through with some of the easement issues as it pertains to the UDO not being in line with our policies or the NCDOT policies. He looks forward to working with Mark and the rest of the staff to help alleviate the issue.

Mr. Trego asked if it would be beneficial to make a presentation to the Council, we would be more than willing to do so. He will push it forward to the Mayor and the City Manager.

PWCORD2020-25

Attached is an Electric and W/WW Fund budget ordinance amendment #3 for Commission action at the August 26<sup>th</sup> meeting.

PWCORD2020-25 is an Electric and Water/Wastewater Fund amendment changing the fund balances as follows: The Electric Fund is increasing by \$6,743,800 to \$270.0 million and the Water/Wastewater Fund is increasing \$533,400 to \$143.1 million.

Within this budget amendment are increases in expenditures referred to as "encumbrance carryforward". This is a governmental budgeting term that basically means that an expenditure was committed via a purchase order in the prior year's budget, was not fully completed in the prior year as anticipated, and will be completed in this fiscal year with carryforward funds from the prior year. Section 5 of the Budget Ordinance adopted for FY 2021 allows for these carryovers.

#### Electric Fund

- <u>Electric Fund Revenue</u>: Total Electric Fund Revenue increased \$6,743,800. Appropriation from Net Position increased \$6,743,800 as a result of the expenditures noted below
- **FY20 Purchase Order Encumbrance Carryforward to FY21:** The impact of the purchase order encumbrance carryforward from FY20 to FY21 on the Electric Fund Expenditures was \$1,841,600 as follows. Capital Expenditures increased \$1,566,300 for capital projects not completed by fiscal year end and Operating Expenditures increased \$275,300 for professional service-related expense.
- Electric Fund Expenditures: Total Electric Fund Expenditures increased \$6,743,800. Of this amount, \$1,841,600 was due to the purchase order carryforwards as mentioned above. Also included is an increase in Power Supply expense of \$4,910,200. This is to reverse the 2019 Duke Energy Progress true-up credit included in FY21 Budget Amendment #2 (PWCORD2020-20). The actual credit was recorded in June 2020 to accurately record the timing of the credit. The remaining amount is due to a decrease in finance costs of \$8,000. This amount was included in FY21 Budget Amendment #2 (PWCORD2020-20) for anticipated Moody's surveillance fees but these expenses have already been included in the original FY21 budget.

#### W/WW Fund

- <u>W/WW Fund Revenue</u>: Total Water/Wastewater Fund Revenue increased \$533,400. Appropriation from Net Position increased \$533,400 as a result of the expenditures noted below.
- **FY20 Purchase Order Encumbrance Carryforward to FY21:** The impact of the purchase order encumbrance carryforward from FY20 to FY21 on the Water/Wastewater Fund Expenditures was \$989,800 as follows. Capital Expenditures increased \$712,000 for capital projects not completed by fiscal year end and Operating Expenditures increased \$277,800 for professional service-related expense.
- W/WW Fund Expenditures: Total Water/Wastewater Fund Expenditures increased \$533,400. Of this amount, \$989,800 was due to the purchase order carryforwards as mentioned above. This is partially offset by a decrease in other finance costs in the amount of \$456,400. This amount was included in FY21 Budget Amendment #2 (PWCORD2020-20) for anticipated costs relating to two state loans and Moody's surveillance fee but these expenses have already been included in the original FY21 budget.

Staff recommends that the Commission adopt the attached budget ordinance amendment PWCORD2020-25.

SUBJECT: Capital Project Fund (CPF) Budget Ordinance

Attached is the CPF budget ordinance for Commission action at the August 26<sup>th</sup> meeting and below is a summary explaining the purpose:

 PWCORD2020-26 establishes a \$10.7 million P.O. Hoffer-Glenville Lake WTP's Reliability Improvements State Revolving Loan Capital Project Fund for a project to be funded with State Loan proceeds. This loan was applied for in Spring 2020 and PWC received a letter of intent to fund dated August 3, 2020. This fund is needed now to establish budgets in support of executing engineering task authorizations and Right-of-Way activity.

Staff recommends that the Commission adopt the attached budget ordinance.

# CAPITAL PROJECT ORDINANCE PO HOFFER-GLENVILLE LAKE WTP'S RELIABILITY IMPROVEMENTS SRL CAPITAL PROJECT FUND PWCORD2020-26

BE IT ORDAINED by the Fayetteville Public Works Commission (PWC) that pursuant to Section 13.2 of Chapter 159 of the General Statutes of North Carolina, the following capital project ordinance is hereby adopted:

- Section 1. The project authorized is for the funding of the PO Hoffer-Glenville Lake WTP's Reliability Improvements project to be financed by the proceeds from a State Revolving Loan.
- Section 2. The officers of this unit are hereby directed to proceed with the project within the terms of the loan documents and within the budget contained herein.
- Section 3. The following revenues are anticipated to be available to complete the project:

State Revolving Loan Proceeds \$ 10,719,300

Section 4. The following amounts are appropriated for the project:

Project expenditures \$ 10,719,300

- Section 5: Funds may be advanced from the PWC General Fund for the purpose of making payments as due and reimbursement requests will be made to the funding agency in an orderly and timely manner.
- Section 6. Copies of the capital project fund ordinance shall be made available to the PWC budget officer and finance officer.
