



**AREA LIGHTING SERVICE**

**(THIS SCHEDULE IS CLOSED to NEW INSTALLATIONS as of DEC 1, 2015)**

**AVAILABILITY** Available throughout the territory served by the Public Works Commission in accordance with the Commission's established service regulations.

**APPLICABILITY** For dusk-to-dawn electric service used for illuminating private outdoor areas. Service under this schedule is not available for illuminating indoor areas or public thoroughfares.

**CHARACTER OF SERVICE** Service shall generally consist of a luminaire owned, installed, powered and maintained by PWC.

**MONTHLY RATE**

**A \$4.50/month charge can be added to the luminaire charge for additional facilities needed for Light.**

THIS SCHEDULE IS CLOSED to NEW INSTALLATIONS as of DEC 1, 2015)

**FACILITIES CHARGES** Provisions for additional facilities as needed or as requested shall be assessed prior to installation. Additional facilities which may include trenching, conductors, transformers, etc. may be considered as one-time charges or included in the monthly rate, as delineated in the PWC service regulations.

**WHOLESALE POWER COST ADJUSTMENT (WPCA)** All stated rates are subject to a monthly wholesale power cost adjustment (WPCA).

**CONTRACT PERIOD** As detailed in the service regulations, the contract period for area lighting service shall be three years for regular area lights and ten years for decorative area lights.

**PAYMENTS** Bills are due when rendered and are payable within 20 days. If a bill is not so paid, PWC has the right to suspend service in accordance with the provisions of the PWC's service regulations.

**TAX** Applicable North Carolina Sales Tax will apply.
