In September 2020, the North Carolina Department of Environmental Quality (DEQ) offered PWC a \$17,912,000 State Loan for the Rockfish Creek Basin Peak Flow Facilities Project (Project) to the terms of 20 years, 1.11% interest and 2% closing fee. To accept this loan offer, PWC and the City of Fayetteville (City) must adopt a resolution accepting the loan in the form provided by DEQ.

- E. Approve contract award for the Rockfish Creek Basin Peak Flow Facilities Project to J. Cumby Construction, Cookeville, TN, the lowest responsive,

responsible bidder in the total amount of \$11,170,485.00, and forward to City Council for approval.

Commission is also requested to approve PWC Resolution – PWC2020.14 in connection with the tentative award of the bid contract and authorize staff to submit a similar resolution to the City of Fayetteville for execution.

This project will construct off-line wastewater storage facilities necessary to prevent sanitary sewer overflows in the Rockfish Creek Basin interceptor system during periods of peak flows and/or extreme wet weather. This project is also needed because of increasing flows in the Rockfish Creek Basin due to the ongoing extension of wastewater service to annexed areas of Fayetteville and to support future growth potential in the south and western areas of Fayetteville. The construction of the basin is the least cost alternative to increase peak flow capacity in this area, being less than half the estimated cost of running a parallel 36” wastewater main.

Funding for this project is from WS-57 Rockfish Creek Basin Peak Flow Facilities (CPR10000135) for \$11,170,485.00. All project costs deemed eligible will be reimbursed from loan proceeds administered by the NC Division of Water Infrastructure via the Clean Water State Revolving Fund (CWSRF) Program (SRF Project No. CS370434-14)

**COMMENTS:** Notice of the bid was advertised through our normal channels on August 14, 2020, with a bid opening date of September 29, 2020. Addendum No. 1 was issued on August 18, 2020 to address Contract Document Revisions, Addendum No. 2 was issued on September 17, 2020 to answer questions, and provide minutes from the Mandatory Pre-Bid. Addendum No. 3 and No. 4 were issued on September 25, 2020, to address Contract Document Revisions and to provide response to additional questions received from prospective bidders. Fourteen (14) General Contractors and seven (7) local subcontractors attended the mandator pre-bid. **SDBE/Local Participation:** J. Cumby Construction is not a local firm. The bidder identified two (2) DBE firms for a total of \$134,553.00 in DBE spend. One (1) of the DBE firms is local from Hope Mills, NC (Patriot Hauling). J. Cumby Construction, Inc., also identified potential local spend for supplies and other expenses in the amount of \$370,000.00 in the following categories: concrete, concrete accessories, lodging and small tools.

- F. Approve bid recommendation to award bid for purchase and installation of boiler tube replacement equipment for three (3) heat recovery steam generators at the PWC Butler Warner Generation plant to Vogt Power International, Louisville, KY, the lowest responsive, responsible bidder in the total amount of \$8,309,000.00, and forward to City Council for approval.

The current equipment was installed in 1987 and is near the end of its service life. This equipment is being replaced now to improve plant reliability to meet the Delivery Performance Factor contained within our Duke Energy Progress power supply contract. Performance of the plant plays a significant role in the amount of savings that can be achieved under the power supply contract.

The Boiler Tube Replacement Equipment and Installation for three (3) Heat Recovery Steam Generators at the PWC Butler Warner Generation Plant Project is funded from EL46 BWGP Heat Recovery Stem Generator Boiler Tube Replacement (CPR1000473) for \$8,309,000.00.

In accordance with N.C.G.S. 143-129 purchase of apparatus, supplies, materials, or equipment, no minimum number of bids are required, and recommendation of award is to Vogt Power International, as the lowest responsive, responsible bidder.

**COMMENTS:** This specialized equipment is complex in nature requiring significant manufacturing time with installation expected to be complete December 2021. Notice of the bid was advertised through our normal channels on July 14, 2020, with an original bid date of August 13, 2020. Addendum No. 1 was issued on July 27, 2020. The addendum was to provide minutes and questions from the mandatory pre-bid and to extend the bid opening to August 20, 2020. Addendum No. 2 was issued on August 12, 2020 to provide responses to questions from bidders and to modify the contract document to include performance and payment bonds. Three (3) bidders attended the mandatory pre-bid, two (2) bids were received during the bid opening. **SDBE/Local Participation:** Vogt Power International, Louisville, KY, is not classified as a SDDBE, minority or woman-owned business. The bidder identified potential local spend of \$1,895,000.00 in the following categories: crane services, scaffolding, local labor (welders and boiler makers), equipment rentals, and food and lodging.

- G. Approve bid recommendation to award bid for purchase of two (2) 33,000 GVWR Cab & Chassis Equipped with HD150 ABDW Service Body and PTO Mounted Compressor to White's International, Greensboro, NC, the lowest responsive, responsible bidder in the total amount of \$245,586.88, and forward to City Council for approval.

The two (2) 33,000 GVWR Cab & Chassis Equipped with HD150 ABDW Service Body and PTO Mounted Compressor is a budgeted item for \$260,000.00, as stated below.

I. REGULAR BUSINESS

Chairwoman Evelyn Shaw called the meeting of Wednesday, September 23, 2020, to order.

APPROVAL OF AGENDA

Commissioner Rogers motioned to approve the amended agenda. The motion was seconded by Commissioner Fowler and unanimously approved.

### III. SAFETY DISCUSSION

Requested by: Commissioner Darsweil Rogers

Commissioner Rogers requested for there to be a Safety Presentation during a Commission Meeting so they can become more knowledgeable about PWC's safety environment. He is also requesting for there to be a report during each meeting.

Mr. Trego stated he receives a report from Human Resources that reviews our incidents. He receives it with Mr. Russell and Mr. Campbell each month. He stated we can include it with the Commissioners' Reports and Information. He suggested having a monthly discussion or quarterly one, based on the Commission's preference.

Commissioner Rogers stated he certainly wants the presentation, so they are knowledgeable of the reports as well as the trends. And he wants the safety stats to be reported each meeting.

### IV. GENERAL MANAGER REPORT

POST EO 124/142

Mr. Trego stated the Executive Order ended during the end of July. He stated based on the EO, we could not disconnect customers and their bills were allowed to grow. According to the EO, we could allow customers up to six months to pay their arrears. We automatically placed all customers with arrears on six month plan. We have encouraged customers to call in if they have difficulties paying their bills. For those customers who have not paid their bills and have not called they are beginning to receive severance notices and we are beginning the process.

Mr. Trego asked Rhonda Haskins to give the Commission a summary regarding the number of customers in arrears as well as total dollars.

Ms. Haskins stated in July we estimated 20,000 residential customers @ \$10M. In August we placed approximately 33,000 residential customers on pay plans for a total due of approximately \$11M. Our worst case estimate was \$12M. She stated as of yesterday we have 29,000 on payment plans for a total of approximately \$9M. She stated we normally have a handful of customers (20,000-30,000 ) that will go late but will not go on the disconnect list.

She stated our phone call volume is beginning to pick back up. Prior to March we were averaging 1,800 to 2,000 calls a day. In April, the volume was cut in half to about 800-1000 calls per day. So far this month we have averaged approximately 1,500 calls per day, and on Monday we received 2,000 calls.

Ms. Haskins stated as of yesterday (9/22) 20K residential customers are late for a total due of approximately \$3M (excluding payment arrangement amounts). She stated approximately 4,300 residential customers are at the "greater than" 37 days level, which starts the disconnect process.

On Friday, (9/18) 128 residential customers were disconnected and 91 reconnected the same day. She stated on Tuesday, (9/22) 220 customers were disconnected and 120 reconnected the same day.

Funding assistance. Ms. Haskins stated through the year we receive two types of funds from DSS which is not a part of COVID. Customers are receiving funding for their bills from Action Pathways

as well as Connections of Cumberland County. Mr. Trego stated we are giving the referrals as appropriate to the customers. Discussion ensued.

Mr. Trego also requested for Mr. Brown to provide an update to the Commission on non-residential customers. They were not included in the EO, but we did not disconnect during that time. Mr. Brown stated about 500 were business customers. Essentially all of them are on payment arrangements that will end January. We have only disconnected 30 business customers. There are 41 customers that are on our 'watch' list. These are customers who have not reopened because of the Governor's order. Mr. Brown stated we have heard of approximately 25 businesses that have closed their doors, and 3 national chains that are in bankruptcy but their doors are still open.

## V. COMMISSIONER/LIAISON COMMENTS

Commissioner Rogers

Regarding the BBR, we were in the process of making the transition from a PWC led initiative to a Fayetteville Chamber led initiative. Christine Michaels, the Fayetteville Chamber CEO has accepted a position in Tennessee and Taneshia Kerr has been named the Interim CEO. Commissioner Rogers stated we will continue with our plan and the BBR will move from a yearly big event to monthly virtual events. More information will be forthcoming.

Commissioner Huff

Asked when the governor says we are in Phase III, will more employees report to the workplace? Mr. Trego responded 2/3 of employees now report to their respective building. 1/3 are reporting from home or WFH. We have made special accommodations for employees who have risks. Also, for our call center employees it is more difficult to socially distance, so we have certain groups who are continuing to WFH.

We have tweaked our WFH policy and based on our experience from COVID we have learned a lot. With comments from the Officers, we have modified it and we expect more employees to take advantage of it. Mr. Trego stated when we go into Phase III, he expects more employees to come into the building as opposed to reporting from home or WFH. He noted there are still some decisions to be made.

He went on to state we are looking to complete an entire facility utilization analysis. If everyone is here, we do not have enough parking and basically our office spaces are full. If we can move employees have them report from home, while maintaining productivity it can be an advantage all the way around and save capital dollars.

He stated when the Governor moves to Phase III, we will assess the impact of the services we provide. Additional discussion ensued.

The following resolution is for Commission action at its October 14, 2020 meeting. In September 2020, the North Carolina Department of Environmental Quality (DEQ) offered PWC a \$17,912,000 State Loan for the Rockfish Creek Basin Peak Flow Facilities Project (Project) to the terms of 20 years, 1.11% interest and 2% closing fee. To accept this loan offer, PWC and the City of Fayetteville (City) must adopt a resolution accepting the loan in the form provided by DEQ.

The Project is included in the FY 2021 Capital Improvement Program document with State Loan funds as the funding source (WS 52). The loan offer is based upon total project estimates including contingencies and the actual value of the loan will be the actual costs to construct the Project. DEQ administers the loan similar to a construction loan and PWC will make periodic draws throughout the construction period upon presenting supporting documentation of eligible payments. There is no interest during construction and interest will begin to accrue upon completion of the Project.

Staff recommends that the Commission adopt the attached resolution (Resolution No. PWC2020.13) to accept the State Revolving Loan Offer for the Project and requests the City adopt same.
