REGULAR BUSINESS

Chairman Wade Fowler called the meeting of Wednesday, January 27, 2021, to order.

APPROVAL OF AGENDA

Upon motion by Commissioner Rogers, seconded by Commissioner Shaw, the agenda was unanimously approved.

CONSENT ITEMS

Upon motion by Commissioner Rogers, seconded by Commissioner Shaw, Consent Items were unanimously approved.

- A. Approve Minutes of meeting of January 13, 2021
- B. Approve bid recommendation to award bid for purchase of one (1) Forestry Track Cutter to Gregory Poole Equipment, Hope Mills, NC, the lowest, responsive, responsible bidder in the total amount of \$113,059.00 and forward to City Council for approval.

The Forestry Track Cutter is a budgeted item (budgeted amount of \$115,000.00).

COMMENTS: Notice of the bid was advertised through our normal channels on December 9, 2020, with a bid opening date of January 13, 2021. Bids were solicited from eleven (11) vendors with two (2) bids received during the bid opening. **SDBE/Local Participation**: Gregory Poole Equipment, Hope Mills, NC, is a local business and is not classified as a SDBE Minority or Woman-Owned business.

C. Approve bid recommendation to award bid for eighteen (18) 27KV Class 1200 AMP Vacuum Circuit Breakers Magnetically Operated to National Transformer Sales (NTS), Raleigh, NC, the lowest, responsive, responsible bidder in the total amount of \$570,420.00 and forward to City Council for approval.

The eighteen (18) 27KV Class 1200 AMP Vacuum Circuit Breakers Magnetically Operated are budgeted items (budgeted amount of \$570,420.00 in the EL-22 Miscellaneous Replacements, Black and Decker Rebuild, and PO Hoffer Rebuild funds).

Bids were received on December 29, 2020, as follows:

** Bidder did not meet the bid specifications.

COMMENTS: In accordance with N.C.G.S. 143-129 purchase of apparatus, supplies, materials, or equipment, no minimum number of bids are required. Notice of the bid was advertised through our normal channels on November 25, 2020, with a bid opening date of December 29, 2020. No addendums were issued for this bid. Two (2) bids were received during the bid process. The bids were evaluated by Electric Support Services, Substations to ensure compliance with PWC Specifications. The bid received from PowerTech, LLC, Waxhaw, NC, did not adhere to the plans and specifications of the bid documents. Bidder took exceptions to the required Arc-Flash Resistance Enclosure. This Arc-Flash Resistant Enclosure is a safety related requirement within the bid specifications to prevent potential hazards to employees and reduce concerns for employee safety should there be a possible eruption within the breakers. **SDBE/Local Participation**: National Transformer Sales (NTS), Raleigh, NC, is not a local firm or classified as a SDBE, minority or woman-owned business. NTS intends to perform 100% of the work.

D. Approve the bid recommendation to award the Annual Construction Services Contract for Transmission Services to Carolina Power & Signalization, Inc., Fayetteville, NC, the lowest responsive, responsible bidder, in the total amount of \$9,253,687.82, and forward to City Council for approval.

This contract will provide transmission construction for repairs, maintenance, and other electric transmission services. The contract may be renewed annually for up to five (5) additional years upon the mutual agreement of both parties.

Funding for this project will be from Electric Construction, Transmission for construction repairs, maintenance, and other electric transmission services. The costs incurred under this contract will depend upon the type and quantities of individual work units that are completed during any given year.

Note: The evaluated costs shown are based upon unit prices submitted by the bidders against estimated quantities of work. Actual costs for work performed will vary in any particular year and may be higher or lower than the evaluated costs.

COMMENTS: The contract will be effective from the commencement of contract award until the end of the current fiscal year, June 30, 2021, and may be renewed annually for up to five (5) additional years upon mutual agreement from both parties. Notice of the bid was advertised through our normal channels on November 11, 2020, with an original bid opening date of December 9, 2020. Addendum No. 1 was issued on December 8, 2020, to respond to questions received by prospective bidders, address Contract Document Revisions, and extend the bid opening date to December 29, 2020. **SDBE/Local Participation:** Carolina Power & Signalization is a local firm. They anticipate no SDBE spend for this contract.

E. Approve PWC Resolution – PWC2021.03 – to Accept a State Loan Offer Under the North Carolina Water Revolving Loan and Grant Act of 1987

In January 2021, the North Carolina Department of Environmental Quality (DEQ) offered PWC a \$16,162,109.00 State Loan for the Big Rockfish Sanitary Sewer Outfall Project to the terms of 20 years, 1.89% interest and 2% closing fee and a \$6,255,105.00 State Loan for the Big Rockfish Sanitary Sewer Outfall – Lift Station Elimination Project to the terms of 20 years, 0.00% interest and 2% closing fee (Project(s)). To accept both loan offers, PWC and the City of Fayetteville (City) must adopt a resolution accepting both loans in the form provided by DEQ.

F. Approve bid recommendation to award contract for the Big Rockfish Creek Outfall – Contract 1 to Sanford Contractors, Lemon Springs, NC, the lowest responsive, responsible bidder in the total amount of \$7,895,205.15, and forward to City Council for approval.

Commission is also requested to approve PWC Resolution – PWC2021.04 in connection with the tentative award of the bid contract and authorize staff to submit a similar resolution to the City of Fayetteville for execution.

This outfall extends under the future NCDOT I-295 interstate highway and includes demolition of the existing #100 Steeple Chase Lift Station and demolition of #114 Lake Upchurch Lift Station and connection to the main outfall.

The Big Rockfish Creek Outfall – Contract 1 is funded in the total amount of \$7,895,205.15 (budgeted in WS-76 Big Rockfish Creek Outfall – Contract 1, and WS77 Big Rockfish Sanitary Sewer Outfall – Lift Station Eliminations). All project costs that are deemed eligible will be reimbursed from loan proceeds administered by the North Carolina Division of Water Infrastructure via the Clean Water State Revolving Fund (CWSRF) program (SRF Project No. CS370434-15/16).

COMMENTS: Notice of bid was advertised through our normal channels on November 14, 2020, with a scheduled bid opening date of December 15, 2020. Addendum No. 1 was issued on November 24, 2020, to provide minutes of the Pre-Bid Meeting and to address Contract Document Revisions. Addendum No. 2 was issued on December 8, 2020, to address Contract Document Revisions. Addendum No. 3 was issued on December 10, 2020 to respond to questions received from prospective

bidders, to address Contract Document Revisions, and to extend the originally scheduled bid opening to December 17, 2020. Addendum No. 4 was issued on December 11, 2020, to provide clarity to responses to questions in Addendum No. 3. Addendum No. 5 was issued on December 15, 2020, to provide clarity to responses from questions in previously issued addendums. Addendum No. 6 was issued on December 21, 2021 to re-advertise the project with a new bid opening date of January 6, 2021, as the scheduled bid opening of December 17, 2020, failed to produce three (3) bids. SDBE/Local Participation; Sanford Contractors, Lemon Springs, NC, is not classified as SDBE, minority or Woman-Owned business. Their bid as 0% DBE participation, but meets the DBE good faith efforts. The bidder identified potential local spend of \$597,000.00 in the following categories: Concrete (S&W Concrete, Fayetteville, NC); Lodging (Homewood Suites, Fayetteville, NC), and Materials/Supplies (Ferguson Waterworks, Hope Mills, NC).

G. Approve the following Capital Project Fund Amendments, which will be effective upon adoption:

GENERAL MANAGER REPORT

Elaina Ball, PWC CEO/General Manager stated since our last meeting, we have started new initiatives. They are:

Supply Chain Improvement Team

This team was kicked off last Friday. This is an employee led initiative. This team will focus on:

- > Cycle Time
- Spend Management
- Supplier Diversity and Local Supplier Engagement

As the team works through opportunities for improvement and implements them, Ms. Ball will update the Commission on their progress.

Policy and Procedures Initiative

Ms. Ball stated we have a lot in our 616 page Policy or Procedures Manual that are a mixture of important items, including our capital structure and our financing philosophy, to tactical minutia and other things we should not control. In addition, virtually everything comes to the CEO for approval. Ms. Ball stated it is important to delegate authority as well as responsibility. It teaches our leaders how to make decisions as well as how to judge business risks.

Performance Management Initiative
 This initiative will be headed by Bobby Russell. It will dovetail into the HCM (Human Capital Management) Solution. Performance reviews are done every day. We do not have annual performance

reviews. We have a mix of attributes and goals. We need to retool that system and we will do so in connection with the technology.

The recommendation for the HCM system is in process. The team evaluated approximately seven demos. Mr. Russell stated the HCM will be a total replacement of the current system, dealing with employee transition, as well as onboarding, salary and benefit administration. Mr. Russell stated anything centered on the human capital aspect, this system should be able to monitor and streamline the process.

Ms. Ball stated Jon Rynne's team is working on a Request for Qualifications for a Consulting Firm to help us evaluate longer term power generation options for our generating station. Mick Noland's team is working on the budget as well working diligently to get projects scoped and bid for our anticipated bond issuance this year.

Ms. Ball stated we recently held our meeting with the City of Fayetteville. Among other topics, we are gearing up to begin Metronet's deployment. The City will hold monthly coordination meetings with all the parties, and we will be active participants.

Regarding Metronet, we received the final batch of executed service agreements yesterday. Legal and Finance are completing QA and audit. Ms. Ball plans to execute them today and will send to Metronet their signed Pole Attachment Agreement. The City Manager has requested a copy and Ms. Ball will send one with the approval of Metronet.

We have requested to join the City's Supplier Availability and Disparity Study. This is a regional study they will do to identify both potential suppliers based on NAICS codes, as well as where there is supply and suppliers are not being awarded. Ms. Ball stated it is good for PWC to join this study. Once she knows the cost to PWC she will inform the Commission.

Chairman Fowler and Ms. Ball met with the Mayor and some in the development community on infill development challenges. She stated we have follow-up meeting with the City regarding creation of some opportunity zones. Ms. Ball suggested the Commission have a policy level discussion in the future regarding how we approach development.

Ms. Ball met with the Colonel Pence, the Fort Bragg Garrison Commander. She stated we have a possible partnering for service men and women returning to civilian life. More information will follow.

Payment arrangements are coming to their six month end. We are studying the data and will begin to conclude the payment arrangements in the near future and return to our normal billing and collection activities. Once we have analyzed all the data and developed a policy, Communications will develop a comprehensive communications plan for customers during this time. Will update the Commission once we have recommendations. We have also been working diligently and continue to look for ways to have assistance for our customers, collaborating with the City and other stakeholders on customer bill assistance.

We have several in-flight technology projects, and how we track time, attendance and conduct payroll has come to light. We do a great job, though we are likely to move many of these functions to a third party. We have over 600 hours a year in IT; team members in Finance who spend a large amount of time on this. We will have a one pager that will show the cost and benefits. No employment will be impacted.

RECOGNITIONS

Fayetteville Tech (FTCC) Electrical Line Worker Class is now at 368 hours since it began in 2018. He has had seven classes serving over 68 students. Fifty-one have gotten a job. We began a new class on January 25 with 12 students. Ms. Ball stated when she met with Dr. Keen, he was excited about the program and is looking forward to expanding it to Water.

Regarding Metronet – Ms. Ball wanted to not only recognize Jon Rynne and Jamie West, but also David Deschamps; Marc Tunstall, Keith Reid, Rick Anderson, and the others who worked countless hours in contract negotiations and assisted in formalizing a lot of the process work.

Commissioner Shaw stated the State allocated \$30M for companies like Metronet to provide services to those digital deserts. A lot of them are rural and some of them are close to cities but service has not been extended to that area. She asked if it would be appropriate to encourage the City to encourage Metronet to apply for some of those funds so they can address some of those digital deserts in our area as they deploy.

STRATEGIC PLANNING

Presented by: Elaina L. Ball, PWC CEO/General Manager

Ms. Ball stated we will review the progress to date; discuss the work to be completed; review and affirm the Vision, Mission and Values; discuss strategic priorities and finalize them; and then discuss next steps.

Ms. Ball stated over the past year, PWC and the consultant have:

- 1. Established the organization's Vision statement
- 2. Updated the organization's Mission statement
- 3. Worked collaboratively with employees to select the organization's key Values
- 4. Segmented customers
- 5. Obtained Community Advisory Group input
- 6. Conducted business unit SWOT analyses

The above information is available to the Commissioners if they desire it.

Over the next quarter, the Staff and Commissioners need to:

- 1. Affirm the work to date
- 2. Select Strategic Priorities
- 3. Identify Goals (Key Performance Indicators) for the Strategic Priorities

 ✓ The management team will draft them for review and input by the Commission
- 4. Identify Initiatives to accomplish the Goals

SUBJECT: Request Approval to Condemn Easement Parcels -Phase V Annexation, Project Areas 24A and Area 24BC

Staff recommends condemnation of seven (7) easement parcels necessary to proceed with construction, installation, operation, and maintenance of main sanitary sewer lines in the Phase V Annexation Project Areas 24A (Hoke Loop Road) and Project Area 24BC (Cliffdale Road), all located in Fayetteville, Cumberland County, NC. The sewer mains consist of primarily 8" pipeline, with associated manholes and services laterals to serve individual properties.

One of the seven easement parcels is located in Project Area 24A which is currently in construction. All 50 easements parcels have been acquired and or settled; however, in the course of surveying the easements, a "gap" between established property lines on Hodhat Drive based on deed descriptions on record was discovered. This gap does not have a PIN number and is not being taxed. Legal counsel has advised that the interest of any known or unknown heirs of the original landowner of the larger parent tract be condemned to assure PWC secures free and clear rights within the proposed easement where the pipeline will be installed.

Project Area 24BC is anticipated to go to construction May 1, 2021. There are 53 easement parcels of which all but 6 have been acquired, settled, or agreements reached. These remaining six are where the owners could not be reached, were unresponsive, and or efforts to negotiate were unsuccessful.

The recommendation, as approved by the Fayetteville Public Works Commission, shall be placed as an Administrative Agenda Item on the City Council Agenda in accordance with prior agreed upon procedure.

PWC will continue to make every effort to negotiate settlement on these claims as condemnation is always a last resort; however, this action is necessary to initiate the legal process to gain possession of the easement parcels in the time frame needed to meet the Project Construction Schedule.

WHEREAS, PWC has determined at this time that its utility operations should be extended, enlarged, and improved by the acquisition of utility easements on and crossing the properties specified hereinbelow in the name of The City of Fayetteville, by and through PWC, and that such acquisitions are necessary and in the public interest for the benefit and use of the public, specifically by and through the establishment, extension, enlargement, or improvement (to meet the need for expanded or upgraded service) of an adequate and sound system of transmission and distribution of electricity, water supply and distribution, and sanitary sewer lines and systems;

WHEREAS, PWC has the authority under Section 6A.8 of Chapter VIA of the Charter of The City of Fayetteville to delegate certain duties and responsibilities when necessary or convenient for its operations, including but not limited to the execution of contracts, settlement statements, instruments, and other legal documents necessary for the acquisition of interests in real property, which shall be titled in the name of the City of Fayetteville, by and through PWC; and

WHEREAS, PWC has deemed that the delegation of certain duties and responsibilities specified hereinbelow are consistent with PWC's authority and fiduciary responsibilities.

THEREFORE, LET IT BE RESOLVED BY THE COMMISSIONERS OF FAYETTEVILLE PUBLIC WORKS COMMISSION THAT:

1. Fayetteville Public Works Commission, acting by and through its General Manager, is hereby authorized to acquire by condemnation, for the purposes stated above in the name of The City of Fayetteville, the property rights and interests described as follows:

a. **Phase V Annexation, Project Area 24A**; Permanent and Temporary utility easements ranging approximately 10-feet to 20-feet in width across that parcel of land located on Hodhat Drive referred to as the "Gap-A" Parcel (unassigned PIN) and being the interest of any Known or Unknown Heirs located off Hoke Loop Road being bounded on the North, South, East, and West by Parcel PINS 9477-73-1577, 9477-63-9585, 9477-63-8507, 9477-63-6398, 9477-63-5590, 9477-63-5409, 9477-63-4638, & 9477-63-9828.

b. <u>Phase V Annexation, Project Area 24BC</u>; Permanent and Temporary utility easements ranging approximately 10-feet to 20-feet in width across the following designated Parcels: Tax PIN(s): 9477-92-6671, 9477-92-6064, 9477-92-7043, 9487-00-0628, 9487-00-3265, 9487-01-5705

All being in Cumberland County, for the purpose of improving PWC's existing and proposed water and or sanitary sewer lines and systems necessary to extend and provide these services where practical and feasible to the Phase V Annexed Project Areas and to ensure an adequate and sound system of water and sanitary sewer lines.

2. The General Manager is authorized to direct the attorney(s) representing Fayetteville Public Works Commission to institute the necessary legal proceedings under Chapter 40A of the North Carolina General Statutes to acquire the easements described hereinabove

3. Pursuant to Section 6A.8 of Chapter VIA of the Charter of The City of Fayetteville, PWC delegates authority to the CEO and General Manager to award and execute contracts, settlement statements, instruments, and other legal documents necessary for the acquisition of interests in real property, which shall be titled in the name of the City of Fayetteville, by and through PWC. This delegation is subject to the requirements and limitations contained within PWC's approved policies.

SUBJECT: Request Approval to Condemn Easement Parcels -Big Rockfish Creek Sanitary Sewer Outfall

Staff recommends condemnation of an additional sixteen (16) easement parcels necessary to proceed with the installation, operation, and maintenance of Big Rockfish Creek Sanitary Sewer Outfall in the area of West Fayetteville. The outfall commences at Golfview Drive just south of Hope Mills and follows creeks, lakes, and low-lying areas westward to the Hoke County Line thence turns North to King Road. The Outfall consists of a combination of 18-inch and 24-inch of gravity sanitary sewer outfall and 12-inch and 8-inch gravity sanitary sewer main designed to eliminate six (6) existing sanitary sewer lift stations currently serving multiple subdivisions in the area. The Outfall will provide the infrastructure needed to make sanitary sewer available and expand capacity for future growth and development, much of which is being fueled by the new I-295 Fayetteville Outer Loop. The six (6) existing lift stations to be eliminated currently require costly ongoing maintenance. the proposed Big Rockfish Creek Outfall will also serve to eliminate the need for a regional lift station and provide necessary tie-in points for installation of gravity sanitary sewer collection systems proposed for future Phase V Annexation Projects.

Several of these easement parcels are located in Contract Areas 1 & 2 scheduled for construction to begin March/April 2021 that were not on the approved resolution adopted by Commission January 13th. The others are located in Contract Areas 3 & 4 with a construction start date in early 2022. Negotiations are ongoing and we anticipate a settlement on some of these claims prior to the start date; however, to assure possession of the easements in the time frame necessary to avoid delay of the construction these parcels are included on the list as well as the ones we know an impasse in negotiations has been reached and or owners have secured legal counsel to represent them.

The recommendation, as approved by the Fayetteville Public Works Commission, shall be placed as a Consent item on City Council Agenda in accordance with Section 6A.9 of the Charter to request that the City of Fayetteville adopt a resolution authorizing the Fayetteville Public Works Commission to transfer the right of way to DOT in accordance with G.S. 160A-274.

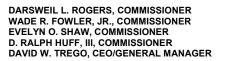
