

Fayetteville Public Works Commission Retro-Commission Program Terms and Conditions

2021 Retro-Commission Program Rules

- Applicant must be PWC non-residential customer with active electric service in good standing.
- Applicant must be medium power non-residential customer.
- Customer must submit Request for Qualifications (RFQ), Request for Proposal (RFP), or statement of work that will be used to hire the Commissioning Provider (CP).
- Customer is solely responsible for selection and payment to a CP for all services rendered.
- All Retro-Commission (RCx) Projects must receive PWC's written approval to receive incentive funds.
- Customer and CP are responsible for, at their own expense, developing project scope, obtaining
 necessary permits, acquiring bids, hiring appropriate licensed contractors, purchasing materials,
 directing labor, applying workforce standards, and any other function associated with the RCx
 Project.
- PWC is responsible for providing twelve (12) months of billing and interval data information to customer and discussing rate implications with the customer and CP provider prior to the start of the RCx Project.
- Projects must be completed and fully operational no later than one (1) year from the date of PWC's written RCx Project approval. Extensions may be granted in writing by and at PWC's sole discretion.
- PWC agrees to incentivize the RCx Project at \$.05/sf, not to exceed \$5,000. Incentives may not
 exceed RCx Project costs. Incentives are paid on a first-come, first-served basis until RCx
 Program funds are depleted.
- Prior to receiving the RCx Project incentive payment, the customer and CP must review completed work with PWC Agents. Customer must provide written certification of RCx Project completion, including detail of work completed, and paid invoices for services, labor, and materials.
- Customer must agree to review operational integrity, interval data performance, and energy savings with PWC Agents on an annual basis for two (2) years after completion of RCx Project.
- These terms and conditions can be modified by PWC at any time.
