### **NOTICE TO BIDDERS:**

This Addendum shall become a part of the Contract Documents for the above project. The selected Contractor shall be responsible for notifying all subcontractors of the contents of this Addendum.

Revised or newly issued wording, drawings, or specifications contained in this Addendum shall supersede and shall take precedence over any conflicting information which was previously issued. All other terms and conditions of the Contract Documents remain unchanged.

### **ITEM 1:** Bid Form Clarification

The Bid Form represents the number of estimated persons for each position, labor hours required for each position, and estimated equipment requirements on a weekly basis. The estimate is based on a 2000-hour work year (50 weeks).

Bidders should calculate the "Estimated Annual Cost" rates using the following formula: Estimated Units Per Week \* Estimated Hours Per Week \* Regular Hourly Rate

Bidders should calculate the "Total Estimated Annual Bid" amount by adding the "Estimated Annual Cost" for Lines 1-40.

### **ITEM 2:**

#### **Bid Bond Clarification**

The Bidders' Bid Bond shall be in an amount of five percent (5%) of Bidder's maximum Bid pricing, meaning the Bidder's "Total Estimated Annual Bid" amount. Bidders should not estimate total contract amount over the five-year period for the bonding amount.

**ITEM 3:** Request for specifications for the transformers.

Response: Detailed technical specifications of transformers will not be included with the bid documents and such specifications should not be necessary for bidders to provide labor hour pricing as required with this bid. The Bid Specifications requires installation of single phase URD/Pad mounted units up to our largest three phase pad mounted and vault type transformers. The various transformers can be found within the samples of the Compatible unit types provided within Addendum No. 2.
