ITEM 1: The following is the questions received from Prospective Bidders

1. Has this project bid before and if so, are those results available?
 - a. This project was previously advertised in June 2021 under project PWC2122001. No award was made from this advertisement; the project is now re-advertised under project PWC2122026.
2. I was hoping we could have the contact information for the Forester
 - a. The Contract will be managed by PWC Electric Construction Department. Direct Point of Contact will be provided to the successful bidder upon contract award.
3. Who is the current contractor you are using for your vegetation management?
 - a. The current contractor is Looks Great Services of MS, Inc.
4. How many miles will be awarded?
 - a. The contract award is a Unit Base Contract, not line miles.
5. Any circuit maps we could be sent?
 - a. A line Circuit map will be provided to the Contractor with every work order packet. Attached within this Addendum is a sample Rural Circuit Map and Urban Circuit Map.
6. Any requirements not mentioned in the RFP that we will need to submit upon completion/Deadline.
 - a. All changes and clarifications to the bid specifications will be issued in writing in the form of an addendum.
7. What is the annual budget for Tree related work?
 - a. The total Annual spend for Fiscal Year 2021 (July 1, 2020-June 30, 2021) was \$840,000.00.
