NOTICE TO CONTRACTORS:

This Addendum shall become a part of the Contract Documents for the above projects as they apply.

Each Contractor shall be responsible for notifying their subcontractors of the contents of this addendum.

Revised or newly issued drawings contained in this addendum shall supersede and take precedence over any conflicting information in the original drawings. Modified or newly issued specifications contained in this addendum shall supersede and shall take precedence over any conflicting information in the original specifications.

<u>Item #1:</u> The deadline for submission of proposals is amended as follows:

GENERAL TERMS AND CONDITIONS

1. In "Paragraph B. Bid Proposal", change the deadline for submittal of proposals from "5:00 pm, Friday, January 21, 2022" to "5:00 pm, Friday January 28, 2022".

<u>Item #2:</u> Questions received from prospective bidders are addressed as follows:

1. Can you provide some clarity regarding the owner provided equipment; will the owner provide all equipment? I know the owner will be providing the 60kW Generator and Pump Control Panel, but will they also provide the ATS, CP, CB, DSU, DS, A/B, A/H, fuel, rigging, light fixture, wetwell floats and probe? Panel LP is existing, who is the manufacturer (assuming we are responsible for adding a 1P 20A breaker to this panel)? Please advise, thanks.

Bidders' attention is directed to plan sheet E-3, note #8 under "DEMOLITON & REVISED ELECTRICAL NOTES". Per note #8, the Pump Control Panel / RTU will be furnished by the Owner (PWC) and installed by the Contractor.

Per the project specifications, all remaining equipment including the 60kW Generator, Automatic Transfer Switch, appurtenances and incidentals will be provided by the Contractor.

The existing Panel LP in the building is a Square D, QO Load center, Cat. No. QO6-12L100.
