NOTICE TO BIDDERS:

This Addendum shall become a part of the Contract Documents for the above project. The selected Contractor shall be responsible for notifying all subcontractors of the contents of this Addendum.

Revised or newly issued wording, drawings, or specifications contained in this Addendum shall supersede and shall take precedence over any conflicting information which was previously issued. All other terms and conditions of the Contract Documents remain unchanged.

ITEM 1: General Terms and Conditions

Bidders are instructed to insert after items 1-30 in the General Terms and Conditions the following:

31. All Materials shall be provided from a State Permitted Pit or Quarry. Bidders shall provide all permits with their bid submittals.

32. PWC reserves the right to request quarry weight tickets from the successful supplier, and upon such request the Supplier shall provide.

All other terms and conditions of the Contract Documents remain unchanged.

ITEM 2: Revised Bid Form

The Bid Proposal Form has been revised. The revised Bid Proposal Form is attached. Bidders are instructed to delete the original Bid Form and utilize the attached.
