- 1. Bids shall be received no later than <u>2:00p.m. on March 31, 2022</u> at which time they will be publicly opened and read aloud by the entrance doors outside of the PWC Administration Building located at 955 Old Wilmington Road, Fayetteville, North Carolina 28301. Late bids will not be considered and will be returned to the Bidder unopened.
- 2. Bids will be examined promptly after opening and an award will be made at the earliest possible date. Award of bid is subject to approval by the Fayetteville Public Works Commission (PWC) and the Fayetteville City Council.
- 3. Bids must be held firm and open for acceptance by PWC for a period of ninety (90) days after bid opening date. This is necessary for approval of award and issuance of purchase order or contract. Submit bids only on the bid proposal form(s) provided herein, or exact copies thereof (See Attachment A).
- 4. Contract award shall be made to the lowest responsive, responsible bidder(s). As used throughout the documents, the terms "contract" or "agreement" refer collectively to the terms, conditions, and provisions set forth in these Instructions to Bidders, the Material Specifications, and Drawings, along with the completed Bid Proposal forms and any purchase order issued by PWC to the Supplier (as defined hereinafter). PWC reserves the right to award contract(s) or purchase order(s) in the best interest of PWC. PWC also reserves the right to reject any or all bids and to waive all informalities concerning bid.
- 5. Bids shall be submitted in a sealed opaque envelope stating on the front of the envelope the bid title and date and time of opening of the bid. - 6. All bids must be signed by an authorized official of bidding entity. Bids may be rejected if for any omission, alteration of form, additions not called for, conditional statements, or any irregularities of any kind.
- 7. Bidders shall not submit alternate bids unless specifically called for on the bid proposal form. To warrant consideration, all proposals must comply with these bid documents. Strict adherence to Material Specifications is requested to facilitate review and consideration of the proposal.
- 8. Delivery shall be F.O.B. Fayetteville Public Works Commission, Warehouse Facility, 1097 Public Works Drive, Fayetteville, NC 28301.
- 9. Payment for any purchases made pursuant to this bid shall be due from PWC to Supplier within thirty (30) days after delivery of the product(s) to PWC consistent with the terms set forth herein and after inspection and acceptance by PWC. Supplier shall ensure delivery of

materials that comply with all of PWC's specifications. If the delivered materials fail to comply with all of PWC's specifications, are damaged, or otherwise defective, Supplier shall promptly upon PWC's request and, at Supplier's sole cost, replace the non-compliant materials with compliant materials. PWC reserves all rights and remedies available under North Carolina law and the applicable provisions of the Uniform Commercial Code set forth in the NCGS for Supplier's delivery failure.

- 10. All questions regarding the Invitation to Bid shall be submitted in writing to Shelby Lesane, Procurement Advisor, by e-mail to shelby.lesane@faypwc.com, no later than <u>5:00</u> p.m., March 21, 2022.
- 11. Bidders are expressly prohibited from contacting any PWC official or employee associated with the Invitation to Bid, except as noted above. Violation of this provision is grounds for the immediate disqualification of the Bidder.
- 12. All changes and clarifications to the Material Specifications and bid documents will be issued in writing by PWC in the form of an addendum. No verbal changes or clarifications will be binding upon PWC.
- 13. The term of this contract shall be for a three (3) year period from date of execution of the contract (the "Term"). The parties may extend the contract for three (3) additional periods of one (1) year each subject mutual agreement in writing signed by both parties (each one (1) year renewal shall also be referred to herein as a "Renewal Period").
- 14. All prices quoted in the bid shall be fixed for purchase orders that PWC issues to the awarded bidder (hereinafter also referred to the "Supplier") during at least the first ninety (90) days of each Term or a Renewal Period. If the bidder proposes to implement variable pricing of goods for which PWC issues purchase orders thereafter solely to reflect any price escalation or de-escalation of the materials used by bidder to manufacture the goods during the remainder of the Term and/or any Renewal Period(s), the bidder shall, in its bid, specify the day of the contract on which variable pricing is to begin (for example, Day 91) and provide any one of the following:

Supplier represents and warrants that it has the capacity and expertise necessary to

manufacture and deliver to PWC the initial forecasted quantity of wood poles. Supplier and PWC will work together regarding any changes in forecast quantities from the initially forecasted amount. Supplier will have the right to review each forecast and if it cannot meet the forecast Supplier will notify PWC within a reasonable commercial time and the parties will agree on a revised forecast. PWC and Supplier will work together to develop mutually agreeable delivery dates, considering PWC's needs and the Supplier's manufacturing schedule.

With this bid opportunity additional quantity of wood poles will be required that are not included within the annual forecast. These quantities are identified in Attachment Band will be used by PWC for a special project separate from our annual needs.

Upon award of the bid PWC will issue a purchase order for the quantity in (Attachment B).

- 16. Lowest Cost: Supplier warrants and represents to PWC that the prices specified for each purchase are and will be as low as the prices at which Supplier is currently selling or will sell or currently intending to sell equivalent wood poles or similar products in the same or similar quantities. If during the Term or a Renewal Period Supplier reduces the prices of the wood poles, in part or in whole, Supplier will: (i) promptly notify PWC in writing of such reduction; and (ii) apply an equivalent reduction in price to all such products ordered by PWC which have not been previously shipped and invoiced at the time of such reduction. The prices thereafter will be adjusted to reflect such reduction for the balance of the Term or Renewal Period or until the prices are further adjusted pursuant to the terms and conditions set forth herein.
- 17. Changes to Purchase Order: All quantities ordered by PWC may be revised as needs change. PWC may at any time make changes in delivery dates, shipping instructions, quantities ordered, or other terms of the purchase order. PWC will confirm such changes in writing, and Supplier will advise PWC in writing if the changes will result in changes to delivery schedules or other changes.
- 18. Termination for Cause: The occurrence of any one or more of the following events will justify termination for cause:
 - d. Supplier's disregard of any applicable laws or regulations of any public body having jurisdiction over PWC.
 - e. Supplier's disregard of the authority of PWC; or
 - f. Supplier's violation in any substantial way of any provisions of the terms and conditions set forth herein.
 - g. Supplier shall not be paid on account of loss of anticipated profits or revenue or other economic loss arising out of or resulting from such termination.
- 19. Termination for Convenience: PWC may terminate the parties' agreement for PWC's convenience without further liability upon thirty (30) days prior written notice to Supplier, and PWC shall be obligated to pay Supplier for the materials ordered and delivered before expiration of the notice period.

- 20. Indemnity: Supplier shall indemnify, defend, and hold harmless PWC and its Commissioners, officers, employees, agents, and representatives (collectively, "Indemnities") from and against all claims, actions, liabilities, damages, losses, costs, and expenses (including, without limitation, injury to or death of any persons and damages to property, economic and consequential damages and attorney's fees) asserted by one or more third parties against one or more of the Indemnitees arising out of negligent or willful acts, violations of laws, infringement of any patent, trademark, trade secret, copyright, or other intellectual property right of a third party, or omissions or breach of the obligations set forth in the parties' agreement by Supplier or any of its employees, agents, representatives, and subcontractors. Supplier's obligation to indemnify, defend, and hold harmless the Indemnitees shall survive the termination of the parties; and shall include the duty to shall survive the termination of the parties; and shall include the duty to pay for the reasonable attorneys' fees and costs associated with defending the Indemnitee(s) by the legal counsel of the Indemnitee's choice.
- 21. Dispute Resolution: The parties' agreement shall be governed by the laws of the State of North Carolina without the application of the laws of any other state. The exclusive venue for all mediations and litigation and any other legal proceedings regarding the parties' agreement shall be the State and Federal Courts serving Cumberland County, North Carolina, and Supplier consents to personal jurisdiction in such courts. Supplier irrevocably waives, to the fullest extent permitted by law, any objection that it may now or hereafter have to the venue of any such suit, action, or proceeding brought in any such court serving Cumberland County has been brought in an inconvenient forum.
- 22. Compliance: Supplier hereby acknowledges that "E-Verify" is the federal E- Verify program operated by the US Department of Homeland Security and other federal agencies which is used to verify the work authorization of newly hired employees pursuant to federal law and in accordance with Article 2, Chapter 64 of the North Carolina General Statutes. Supplier further acknowledges that all employers, as defined by Article 2, Chapter 64 of the North Carolina General Statutes, must use E- Verify and after hiring an employee to work in the United States, shall verify the work authorization of the employee through E-Verify in accordance with N.C.G.S.§64-26(a). Supplier hereby pledges, attests and warrants through execution of the agreement that Supplier complies with the requirements of Article 2, Chapter 64 of the North Carolina General Statutes and further pledges, attests and warrants that all subcontractors currently employed by or subsequently hired by Supplier shall comply with all E-Verify requirements. Failure to comply with the above requirements shall be considered a breach of the agreement. Supplier hereby further acknowledges that the execution and delivery of the agreement constitutes Supplier's certification to PWC and to the North Carolina State Treasurer that, as of the date of the agreement, Supplier is not listed on (a) the Final Divestment List created and maintained by the North Carolina Department of State Treasurer pursuant to the Iran Divestment Act of 2015, Chapter 147, Article 6E of the General Statutes of North Carolina (the "Iran Divestment Act"); or (b) the list of companies that the North Carolina State Treasurer determines to be engaged in a boycott of Israel in accordance with Article 6G of Chapter 147 of the General Statutes of North Carolina. Supplier represents and warrants to PWC that Supplier, and all persons and entities owning (directly or indirectly) an ownership interest in it: (i) are not, and will not become, a person

or entity with whom a party is restricted from doing business with under regulations of the Office of Foreign Asset Control ("OFAC") of the Department of the Treasury (including, but not limited to, those named on OFAC's Specially Designated and Blocked Persons list) or under any statute, executive order (including, but not limited to, the September 24, 2001, Executive Order 13224 Blocking Property and Prohibiting Transactions with Persons Who Commit, Threaten to Commit, or Support Terrorism), or other governmental action; and (ii)are not knowingly engaged in, and will not knowingly engage in, any dealings or transactions or be otherwise associated with such persons or entities described in clause (i) above. Supplier also shall at all times during the term of the agreement comply with Executive Order 11246, including but not limited to the Equal Opportunity Clause requirements set forth in 41 C.F.R. §60-1.4. - 25. Assignment: The Supplier may not assign this agreement or any of its rights, duties or obligations hereunder, or subcontract any of the services to be performed hereunder, without the prior written consent of the PWC.
- 26.
