^{*} The Border States total bid is lower than WESCO's because they did not include pricing for six items within the bid documents. Border States only bid on one item, and they were higher in price than WESCO for the same item.

COMMENTS: Notice of bid was advertised through our normal channels on March 22, 2022, with a bid opening date of April 7, 2022. Bids were solicited from three (3) vendors and two (2) bids were received. The bid consisted of various quantities of seven critical items: bushings, elbows, pedestals, two types of enclosures, load break switch and concrete pads. Due to supply chain disruptions, and long lead times, procuring these items in the quantities should help to prevent potential sock outs of these critical items. **SDBE/Local Participation**: WESCO Distribution, Clayton, NC is not a local business and is not classified as a SDBE, Minority or Woman-Owned Business.

C. Approve bid recommendation to award bid for the purchase of Conductor and Conduit Inventory to WESCO Distribution Inc., Clayton, NC, the lowest, responsive, responsible bidder, in the total amount of \$247,459.99, and forward to City Council for approval.

The Conductor & Conduit Inventory is budgeted in Warehouse Inventory.

Bids were received April 7, 2022, as follows:

RESOLUTION REJECTING ALL BIDS FOR PWC2122028—CABLE CONDUCTOR CONTRACT

WHEREAS, on February 1, 2022, the Fayetteville Public Works Commission ("PWC") advertised for sealed bids to purchase inventory estimated to cost more than ninety thousand dollars (\$90,000) for the PWC2122028—Cable Conductor Contract. Bids were received and opened at 3:00 p.m., on February 24, 2022, at PWC's Administration building.

WHEREAS, four bids were received on February 24, 2022, from the following bidders: Borderstate Electric, American Wire Group, Wesco, and City Electric.

WHEREAS, upon evaluating the received bids, PWC determined the following:

- 1. Borderstate Electric did not provide pricing for thirteen (13) of the fifteen (15) items listed in the bid documents. Its bid is solely for CABLE, 1/0 AL, EPR, 25KV, 1/C, CN and CABLE, 750 MCM AL, EPR, 25KV, 1/C, CN.
- 2. American Wire Group did not provide pricing for two (2) of the fifteen (15) items listed in the bid documents. It failed to provide pricing for CABLE, 1/0 AL, EPR, 25KV, 1/C, CN and CABLE, 750 MCM AL, EPR, 25KV, 1/C, CN.
- 3. Wesco's bid contained a nonwaivable material variance as it did not adhere to the variable pricing of goods requirement detailed in the bid documents.
- 4. City Electric's bid purported to expire twenty-four (24) hours after bids were opened in contravention of the requirement in the bid documents that bids be held firm for acceptance for a period of ninety (90) days. City Electric has indicated it will not honor the prices set forth in its bid.

THEREFORE, LET IT BE RESOLVED BY THE COMMISSIONERS OF THE FAYETTEVILLE PUBLIC WORKS COMMISSION THAT:

- 1. The Commission has determined that all four bids received for the Cable Conductor Contract are nonresponsive and therefore rejected.
- 2. The Commission authorizes staff to readvertise bids for the Cable Conductor Contract in accordance with G.S. 143-129.
