E. Adopt PWC Resolution # PWC2022.18 – Resolution to Declare Personal Property as Surplus and Authorize Sale of Property by Sealed Bid

^{*} The instructions to bidders for this purchase specifically advised bidders to "not submit alternate bids unless specifically called for on the bid proposal form." The bid proposal form did not call for any alternate bids. WESCO Distribution, Inc., submitted an alternate bid for a fixture that has not been evaluated by PWC personnel as an approvable fixture. The alternate fixture does not conform with the specifications set forth in the bid documents. As such, PWC staff determined that the alternate bid submitted by WESCO Distribution, Inc., is non-responsive.

The Fayetteville Public Works Commission ("PWC") owns equipment that is identified in our inventory as "transformer shipment #623-Pad, containing forty (40) padmount transformers, totaling 2,000 kVA" (the "Equipment"). Staff has determined that PWC has no use for the Equipment at this time, and Staff estimates that the value of the Equipment is at least thirty thousand dollars (\$30,000.00). Staff therefore requests that the Commission declare this Equipment to be surplus and authorize the sale of the Equipment via sealed bid in accordance with G.S. 160A-268.

COMMENTS: Staff believes that the Equipment is surplus and requests that the Equipment be declared surplus and authorized for sealed bid.

REGULAR BUSINESS

Chairwoman Evelyn Shaw called the meeting of June 22, 2022, to order at 8:30 am.

APPROVAL OF AGENDA

Upon motion by Commissioner Donald Porter, seconded by Commissioner Ronna Garrett, the agenda was unanimously approved.

INTRODUCTION OF HIGH SCHOOL AND COLLEGE INTERNS

Presented by: Bobby Russell, HR Officer

Mr. Russell presented the 2022 IKON Students and College Interns. He stated PWC has eleven IKON Students interning at PWC this summer, and fifteen College Interns. The students have been tasked with meaningful projects to accomplish for the summer. This program is a part of our strategic recruitment program.

Each student introduced himself/herself, the school attending and the department they have been assigned to during their internship.

Each Commissioner introduced himself/herself to the students, and encouraged the students to make the most of this step in their journey. They commended and encouraged the students to consider a career in the utility industry as the future is bright in this industry.

Commissioner Shaw stated she is absolutely delighted with this program. One of the things she admires most about PWC is they give young people a chance.

Upon motion by Commissioner Wade Fowler, seconded by Commissioner Ronna Garrett, the Consent Items were unanimously approved.

- B. Adopt PWC Resolution # PWC2022.16 Resolution Rejecting All Bids for PWC2122048 One 67kV Delta to 13.09Y/7.56kV With LTC 24/32/40MVA Power Transformers

On April 13, 2022, the Fayetteville Public Works Commission ("PWC") advertised for sealed bids to purchase inventory estimated to cost more than ninety thousand dollars (\$90,000) for the PWC2122048—One 67KV Delta to 13.09Y/7.56KV with LTC 24/32/40MVA POWER TRANSFORMERS. Bids were received and opened at 2:00 p.m., on May 17, 2022, at PWC's Administration building from the following three bidders: Fleming Electric, Inc., Virginia Transformer Corp., and WEG Transformers USA.

PWC budgeted one million dollars (\$1,000,000) for this purchase. All three bids received by PWC for the PWC2122048 bid exceeded one million dollars (\$1,000,000).

Comments: Staff recommends that the Commission reject all bids received for PWC2122048 - One 67kV Delta to 13.09Y/7.56kV With LTC 24/32/40MVA Power Transformers, because all of the bids are in excess of the funds available for the purchase, and authorize staff to revise and readvertise the purchase in accordance with G.S.143-129.

- C. Adopt PWC Ordinance # PWCORD2022-26 Grant Project Ordinance Directed Grant Project Fund
 - ➤ PWCORD2022-26 created the Directed Gant Project Fund to account for a pilot project and related tasks associated with groundwater remediation at the brownfield site owned by the City of Fayetteville known as the TEXFI site. Fayetteville PWC received a directed grant of \$220,000 from the NC Legislature.

Comments: Staff recommends that the Commission adopt the attached budget GPF Ordinance

ELECTRIC RATE RECOMMENDATIONS

Presented by: Elaina L. Ball, CEO/General Manager Rhonda Haskins, Chief Financial Officer

Ms. Ball stated we conduct bi-annual reviews of our electric and our water systems. In alternating years you will see reviews for each of the systems. We conduct the reviews so often to ensure we understand where our cost of service (COS) is moving, and we have the opportunity to update tariffs and rates. We have been going through an electric COS study for the past several months.

Ms. Ball stated the changes we are recommending is in support of three areas of our strategic plan, which are Conservation, Economic Development, and Customer Satisfaction.

Ms. Ball stated in conducting our base rate review we have determined we do not need to raise base rates. We have sufficient cost recovery with our current rates to conduct the electric system.

Ms. Ball stated we will recommend new rates and riders which are:

- New rate design for Whole Home and Whole Small Business EV rates effective February 2023
- New Renewable Energy Buy Back rider effective February 2023
- New Economic Development rider effective September 2022

Ms. Ball stated staff is recommending updated rates, which are:

• Changes in demand qualification and energy rate for Medium Power CP – (remains optional) September 2022, (required) September 2023

Recommended Services Regulations/Charges:

- Fee reductions for Connections/Reconnections and Meter Testing
- Change of name for Wholesale Power Cost Adjustment to Power Supply Adjustment
- Provisions regarding cross connections have been expanded and provisions added to address water shortages
- Consistency edits across the rate schedules

Ms. Ball urged the Commissioners to stop them at anytime if they have questions. She stated Rhonda Haskins, and Finance Team is in attendance, as well as Max Bernt from NewGen (virtual).

Base Rates/Cost of Service – we completed a cost of service study to determine if our rates are sufficient to support the Electric System.

Cost of Service Study Assumptions

- Use of current base rates
- Drawdown of electric rate stabilization fund to keep rates stable through the 2024 time period
- Contingency and capital expenditure plans
- Maintain > 120 days cash on hand for Electric
- Maintain > 2.5 debt service coverage

Cost of Service Study Results

- Cost of service results = \$201.3M
- Prior study = \$201.6M
- ~0.1% difference from 2 years ago
- Reviewed inter and intra customer class cost of service results (discussion ensued)

Distributed Energy

Consultant reviewed Buy All Sell All tariff and found:

- Calculation is administratively burdensome to apply to many small power producers
- Cost of separate generation meter may be cost prohibitive

Recommendation

- Adopt small producer policy (mainly focused on rooftop solar) that applies bi-directional metering
- Simplify calculation of credit
- Maintain Buy All Sell All tariff for larger power producers

Renewable Energy Buy Back

- ▶ Effective February 2023
- Requirements
 - Residential and Small Power Service
 - ▶ Follows applicable rate schedule
 - ▶ 10 kW or less Solar Generation Facility
- Customer Credit
 - Weighted average credit
 - Calendar year based (0.06348 per kWh for CY 2022)
 - Credit cannot exceed monthly energy charge
 - No carry-forward of credit

Commissioner Fowler asked if we currently have bi-directional meters. Ms. Ball replied 'no'. He also asked are looking at the possibility all our meters will be bi-directional meters in the future. Ms. Ball replied this is a first step to recognize change is coming, and set the utility to be a network provider, and have cost recovery that does not disproportionately affect certain customers. (Additional discussion ensued).


Updated Rates

Coincident Peak Rate Benchmarking

- Coincident peak options starting availability is relatively broad in NC (30-500kW)
- Many areas providing complex rate options to 50kW or higher customers

Updated Rates

Medium Power Service - Coincident Peak

- Conservation/Demand Management
- ▶ Balancing change with PWC resources
- Effective September 2022 (optional enrollment)
 - Lowering minimum kW threshold from 200 to 150
 - Energy charge reduced from \$0.04545 to \$0.03925
- ▶ Effective September 2023 (required enrollment)

Customer Service Charges

Ms. Ball stated under our current fees we have a significant difference between our normal business hours and after-hours connection/reconnection fees. In talking with the team, looking at what many other utilities have done and in recognition we are fully deployed from AMI perspective, there is not much of an incremental cost in those actives (on and off hours). In recognition of this and allowing our customers to share in the savings associated with all this automation, we propose to levelize and reduce those fees based on the level of effort. Discussion ensued on the 'Disconnection Attempt Fee'. Staff will re-evaluate the fee, and bring recommendations.

Commissioner Fowler stated it is a nice in this these inflationary we see prices going down. It is a wonderful representation that we really look at the customer and try to give them the best value for what they receive. He commended the staff for their work.

Commissioner Porter asked how will these rates be communicated? Ms. Ball and Ms. Justice-Hinson responded with a detail of how they will communicate the changes.

Ms. Ball requested for the Commission to set a public hearing on the proposed Electric Ratees for July 13, 2022, Commission Meeting.

Commissioner Fowler motioned to hold a public hearing on the proposed electric rates on July 13th. Commissioner Porter seconded, and the motion was unanimously approved.

GENERAL MANAGER REPORT

Mark Brown

Ms. Ball stated it was with deep sadness we learned of Mark Brown's passing last week. Mark has been a terrific team leader, an amazing teacher of his team and an amazing co-worker. He has been with PWC since January 2013. He will be sorely missed. We are planning a memorial for Mark on Wednesday, June 29th @ 9am in the Main Meeting Room.

Drinking Water Health Advisories

EPA passed drinking water health advisories for four PFAS compounds. These health advisories are set to interim levels for a compound called PFOA and PFAS. The interim levels are exceeding low, almost to an undetectable level. Those two interim limits are PFOA at .004 parts per trillion, and PFAS at .02 parts per trillion (neither are measurable with our current technology). For GenX, the health advisory limit is set at 10 parts per trillion, which gives us no pause here at PWC. Our drinking water is well below that level however it does have implications to certain parts of our community that has GenX contamination. PVBS is set at 2000 parts per trillion. That gives us no pause either. For our drinking water supply, the GenX and PVBS levels are well below thresholds. We will continue to watch the interim levels on the other two compounds, but Ms. Ball imagines the scientific community will weigh in at some point regarding measurability. Mr. Noland stated there should be some decisions made later this year that is more scientifically based. Discussion ensued.

Grays Creek

Ms. Ball stated PWC continues to work with the technical team at the County. Mick Noland's team as well as James West continue to be steadfast in working on the issue of providing wholesale water to the district. She stated going back to July 2021 and as late as March 2022, we have been working and sending proposed agreements to effectuate support of the County's desire to offer an alternative water supply to the area. The County's budget does contain support for a phased approach, and PWC remains at the table for a continued discussions of the County's identified needs.

APPA Conference

Ms. Ball stated the APPA Conference was this past week, and several employees and Commissioner attended it. Ms. Ball stated one of the presentations she thought was really interesting was from Marcy Rozelle, a former Chief Economist for CNBC. She gave a thorough and broad overview of our global economy, as well

as recent and expected actions by the Federal Reserve to tamp down inflation and tight monetary policy. Ms. Ball discussed her takeaways from the presentation.

Willie Chi, a Harvard Business School Professor, discussed the supply and demand shock that resulted in a massive bull, that is still plaguing our supply chains and many internationally. He walked us through the automotive supply chain. In the 1st quarter of the pandemic, automotive sales sunk 80% globally, and as a result responded tamped down purchasing activities and that has created a lot of the macro-economic issues around chips. His predictions we will slowly recover from the supply chain shocks, and he believes we will slowly see supply chain gluts. Discussion ensued.

Commissioner Fowler discussed the impact electrification will make on electric utilities. He stated eventually there will be four to five electrified items behind the meter that will be bi-directional. Additional discussion ensued.

PWC Power and Water Conservation Expo

Ms. Ball stated the PWC Power, Water and Conservation Expo will be at Skyview on Hay Street this Friday 10 am to 9pm. Ms. Ball encourages our team members to volunteer and our customers to stop by for tips. We will have give-a-ways, and look forward to our first in-person Power, Water and Conservation Expo since the pandemic.

Customer Credits

Commissioner Shaw asked how the customer will know the process to obtain a credit for the energy equipment they install in their home. Ms. Ball and Mr. Grice responded there is an application online for them to enroll in the program, Once they are enrolled, the customers will receive a credit on their bill. We have a section on our website that outlines all the incentive programs. Ms. Justice-Hinson stated we regularly promote the incentive programs. Commissioner Shaw asked if customers do not use electronics, can customers call to get the application, and staff responded yes. Ms. Justice-Hinson stated we have printed applications at our events like the expo we will have this Friday. Additional discussion ensued.

COMMISSIONER/LIAISON COMMENTS

Commissioner Ronna Rowe Garrett

Commissioner Garrett sends her condolences to Mark Brown's family. She stated she is glad PWC is having a memorial next week. She stated he will be missed here at PWC. She stated she has also seen all the comments from elected officials and others on social media regarding the impact he has had and how they relied on him.

She also commended the team on communications and quickly getting feedback to her regarding an accident on the northside that affected groundwater. She also saw the marketing and publicity go out straightaway.

Commissioner Wade Fowler, Jr.

Commissioner Fowler also sends condolences to Mark Brown's family. He stated he has known Mark since he came to PWC. He was the kind of person that when you meet him, you just know you will love him.

Commissioner Fowler also relayed a complimentary text he received from a PWC customer, and he thanked staff for the reports of outages through the OMS.

Commissioner Donald Porter

Commissioner Porter also sends condolences to Mark Brown's family. He commended Ms. Ball for her leadership during this trying time. He commented on the impression Mr. Brown made on the community group meetings he attended, how he listened and kept his word.

Commissioner Porter stated NC Economic Development awarded Robert Van Geons Economic Development 2022 Outside the Box Award. Commissioner Porter was awarded Emeritus Membership. He said it was a good day for Fayetteville.

Commissioner Evelyn Shaw

Commissioner Shaw she also echoes the sentiments regarding Mark Brown. She hopes to say some words at the memorial on behalf of the Commissioners. We should all be lucky enough for people to say and think positively about us when our time comes. She stated that is why she always encourage people to live like you want people to remember you. She commended Ms. Ball on lending her compassion and support to Mark Brown's family on behalf of this organization she leads. And also as an individual who cared about Mark, and she let his family know that. Commissioner Shaw stated that is the mark of a leader and of a caring human being. We all appreciate it.

Commissioner Shaw asked everyone in attendance today to encourage the young people who came before us today. They are our future, and this is a wonderful program. She stated this is the largest class PWC has had since she has been on the board. She thanked everyone who has taken the time to work with this young people.

RESOLUTION TO AUTHORIZE THE CONDEMNATION OF EASEMENTS AND THE DELEGATION OF AUTHORITY TO THE GENERAL MANAGER

WHEREAS, PWC has determined at this time that its water and wastewater utility operations should be extended, enlarged, and improved by the acquisition of easements across the six (6) properties specified hereinbelow, said easements being acquired in the name of The City of Fayetteville, by and through PWC, and such acquisition is necessary and in the public interest for the benefit and use of the public, specifically by and through the establishment, extension, enlargement, or improvement (to meet the need for expanded or upgraded service) of an adequate and sound system of distribution of water supply and distribution systems, and wastewater collection and disposal systems, consistent with G.S. 160A-311(2) and (3).

THEREFORE, LET IT BE RESOLVED BY THE COMMISSIONERS OF FAYETTEVILLE PUBLIC WORKS COMMISSION THAT:

- 1. Fayetteville Public Works Commission, acting by and through its General Manager, is hereby authorized to acquire by condemnation, for the purposes stated above in the name of The City of Fayetteville, the property rights and interests described as follows:
 - a. Temporary construction easements ranging approximately 10-feet to 150-feet in width and permanent utility easements ranging approximately 10-feet to 37-feet in width across the following designated Parcel PINs for the purpose of establishing, extending, enlarging, or improving PWC's existing and proposed system of distribution of water supply and distribution systems and wastewater collection and disposal systems:

9485-55-7246 9484-67-3318 9486-69-1537 9487-51-9177 9487-22-7261 9487-51-9602

2. The General Manager is authorized to direct the attorney(s) representing Fayetteville Public Works Commission to institute the necessary legal proceedings under Chapter 40A of the North Carolina General Statutes to acquire the easements described hereinabove.

- 3. PWC reserves the right to withdraw the Equipment from sale at any time and the right to reject all bids.
- 4. After the public bid opening, the Commissioners will award the sale to the highest responsible bidder at its next regular meeting, unless all bids are rejected or the Equipment is withdrawn from sale.
- 5. PWC's Chief Administrative Officer is hereby authorized to execute a bill of sale on behalf of PWC to transfer title to the winning bidder.
