Outdoor light emitting diode (LED) luminaire for roadway lighting application with One(1) or more LED arrays consisting of all-die-cast aluminum housing with heat sink, electronic driver and door assembly latched for gloved hand (tool less) access. Luminaire mounted via 4-bolt slip-fitter, adjustable for 1-1/4 to 2 inch pipe arm with leveling adjustment. Minimum warrantee shall be ten (10) years on complete luminaire assembly and finish. Luminaire shall be ARRA/Buy American compliant. Finish color to be GRAY.
