 - Q1. I have a few questions. Under INSTRUCTIONS TO BIDDERS, SPECIFIC BID TERMS Item # 12 Term of The Contract. Is this a 3 Year Contract for several units or is this for 1 Unit taking 3 years to complete due to the Supply Chain Market
A1: One Unit taking three years to complete due to Supply Chain Market
 - Q2. It is physically impossible for Manufacturers to hold pricing for 90 days these days.
A2: Pricing for 90 days upon approval from our Commission and Council. approval would be before 90 days in some instances just depending on the days of our Commission and Council meetings within that month.
 - Q3. It will be necessary for the Chassis Specs to have a "Trailer Air Brake Package To End Of Frame" in order for the Body Manufacturer to Install the Air Brakes for the trailers at the rear of the service body.
A3: Yes, the chassis will need the Trailer Air Brake Package
 - Q4. Could the Chassis Specs add 6 to 8 OEM Accessory Dash Switches so that Body Installer would be able to use those switched for all the electrical accessory Items.
A4: Yes, this can be added to the chassis.
