 - M1. Bidders are informed that bids were received for the Big Rockfish Creek Sanitary Sewer Outfall and Lift Station Elimination Outfall-Contract 2 on July 25, 2023 at 11:00 a.m., but the bids were not opened and were returned to the bidders since only two (2) bids were received. Pursuant to NCGS 143-129, a re-advertisement will be provided to re-bid the project. Bids will be received at the Administration Building, Fayetteville Public Works Commission, North Carolina, 955 Old Wilmington Road, Conference Room 107, Fayetteville, North Carolina, 28301, until 2:00 p.m., Thursday, August 3, 2023. Only those bids from bidders that attended the mandatory pre-bid conference for this project will be received and opened.
 - M2. Detail SS-3=Typical Trench Bottom and Backfill Detail for SDR 26 and C900 PVC Pipe per Addendum 3 shall be replaced in its entirety with the enclosed revised Detail SS-3. The revised detail shall become part of the details included in the issued for bid drawings.
 - M3. Bidders are hereby notified that placement of 12" clean fill and 4" of top-soil shall be provided in all locations where the pipeline (whether it is DI or PVC) traverses manicured/maintained lawns and sod will be placed.

Failure to acknowledge receipt of this addendum may result in rejection of the response.



NOTES:

- 1. FOR TRENCHES REQUIRING SHORING AND BRACING, DIMENSIONS SHALL BE TAKEN FROM THE INSIDE FACE OF THE SHORING AND BRACING.
- 2. NO ROCKS OR BOULDERS 2" OR LARGER TO BE USED IN THE TOP 6" OF INITIAL BACKFILL AND NONE 6" OR LARGER IN FINAL BACKFILL.
- 3. FINAL BACKFILL SHALL BE SUITABLE NATIVE MATERIAL.
- 4. BACKFILL SHALL BE TAMPPED IN 6" LIFTS IN TRAFFIC AREAS, 12" IN NON-TRAFFIC AREAS.
- 5. TOTAL TRENCH WIDTH SHALL BE A MINIMUM OF 1.5 X O.D. OF PIPE.
- ACHIEVE 90% COMPACTION IN BEDDING, HAUNCHING AND INITIAL BACKFILL. SEE CONTRACT DOCUMENTS FOR COMPACTION REQUIREMENTS IN FINAL BACKFILL.
- 7. IF IN MAINTAINED/MANICURED LAWN OR WHERE SOD IS REQUIRED FOR RESTORATION, PROVIDE 4" TOPSOIL, AND 12" CLEAN SELECT FILL FOR FINAL DRESSING OF TRENCH BACKFILL.
- 8. CONTRACTOR SHALL UTILIZE METHODS NECESSARY TO MAINTAIN A FULL 6" OF STONE OVER THE PIPE FOLLOWING EXTRACTION OF TRENCH BOX AND/OR SHEETING.
- CONTRACTOR SHALL ENSURE PIPE COUPLINGS/JOINTS ARE NOT DEFLECTED WHEN TWO PIPES ARE JOINED.
- 10.STONE BEDDING SHALL BE FULLY ENCLOSED IN A GEOFABRIC WRAP EXCEPT WHERE EMBEDMENT ZONE IS SURROUNDED BY TRENCH WALLS COMPRISED OF HARD ROCK. EMBEDMENT ZONE INCLUDES BEDDING BELOW PIPE TO 6" ABOVE TOP OF PIPE.
- 11,COPPER TRACING WIRE IS NOT REQUIRED FOR GRAVITY SEWER INSTALLATIONS. IT IS INTENDED FOR ONLY PVC PIPE THAT IS USED IN PRESSURE APPLICATIONS.
