 - ii. Approximately 22,000 LF of 16-inch Water Main (11,000 LF 16-inch existing)

- 4. Proposals shall not exceed **20 pages**
 - i. Cover letter does not count towards the page limit
 - ii. Certificate of Insurance does not count towards the page limit
 - iii. Page limit includes tabs, dividers, double-sided pages are counted as two pages
 - iv. Any promotional literature, brochures, etc., will count towards the page limit
 - v. 6 total copies of the proposal
- 5. Expected Schedule
 - i. Notice to Proceed expected February 2024
 - ii. 30% Design Submittal by October 1, 2025

- iii. R/W and Utility Date (October 1, 2025)
- iv. 100% Design Complete by February 2027
- v. PWC Easement Acquisition by February 2027
- vi. Construction Schedule (Let Date October 19, 2027)
- 6. Qualifications and experience
 - i. Utility Coordination and conflict resolution services with NCDOT TIP projects
 - ii. Water and sewer design and construction in congested corridors
 - iii. Alternative trenchless construction and rehabilitation techniques
 - iv. Design of large diameter water transmission mains
 - v. Construction services in coordination with NCDOT TIP projects
 - vi. Given the size, scope, and schedule of the NCDOT project, it is expected that decisions will be made based on limited and changing information. Submittals shall show the Firm's ability to be flexible, adaptable, and capable of managing change.
 - vii. Focus on qualifications and experience in this type of design. A detailed design is not required at time of submittal.
