Residential Holiday LED Light Program Application 2023

Terms and Conditions

Customer Eligibility: The Program is valid for Fayetteville Public Works Commission (PWC) residential electric customers with active service. I understand that the amount of the bill credit incentive will not exceed the purchase price of the LED string lights and that I am limited to no more than five (5) incentives per account holder (one boxed strand of lights accounts for one (1) incentive). The total bill credit amount cannot exceed \$40.00.

Holiday Led Light Eligibility: To receive your bill credit, application must be filled out and submitted by January 15, 2024. Holiday LED light strings must be purchased between November 1, 2023—December 23, 2023.

Application Eligibility: Applications must be completed in full and accompanied by the required paid invoices or receipts. Current Program is available for holiday LED light strings purchased between November 1, 2023—December 23, 2023. Funds are limited and applications are processed on a first-come, first served basis.

Bill Credit: PWC bill credit may not exceed the total purchase price of the holiday LED light strings. PWC customer is limited to no more than five (5) incentives per account holder. I understand that if I have closed my account at the address listed on the application and no longer have an open account with PWC before such a time that the bill credit cannot be processed, I will forfeit any bill credit due to me.

Verification: PWC reserves the right to verify sales receipts before issuing bill credit.

Program Modifications: PWC reserves the right to alter or discontinue the Program at any time without notice.
