

# **RESIDENTIAL SERVICE – WHOLE HOME**

**AVAILABILITY** Available throughout the territory served by the Fayetteville Public Works Commission ("PWC") in accordance with PWC's established Service Regulations and Charges.

<u>APPLICABILITY</u> Applicable to electric service used for domestic purposes in and about residential dwelling units as limited by the Service Regulations and Charges.

<u>CHARACTER OF SERVICE</u> Service shall be single-phase or three-phase, sixty hertz alternating current at PWC's standard available voltage except as provided for in the Service Regulations and Charges.

#### **DEFINITION OF PEAK PERIODS**

1. On-Peak Hours (daily, excluding Saturdays, Sundays and Holidays):			
Summer:	(April-October)	3:00 PM to 7:00 PM	
Non-Summer:	(November-March)	6:00 AM to 10:00 AM	
2. Super Off-Peak Hours (daily):	(January-December)	9:00 PM to 5:00 AM	

3. Off-Peak Hours: All hours other than On-Peak Hours and Super Off-Peak Hours.

**<u>POWER SUPPLY ADJUSTMENT (PSA)</u>** All stated rates are subject to a monthly power supply adjustment (PSA).

**<u>COAL ASH RIDER</u>** As specified in the Service Regulations and Charges, a monthly surcharge to recover the share of Duke Energy Progress' cost of cleaning up coal ash that is allocated to PWC.

<b>Contract Private Lighting</b>	\$4.00

**<u>PAYMENTS</u>** All bills shall be paid in accordance with the terms of the Service Regulations and Charges.

**TAX** Applicable North Carolina sales tax will apply.

\*An additional \$4.00 Community Street Lighting charge applies to each meter billed on this rate schedule.
