- **3.** Following are questions received about the solicitation and the SME's answers to the questions.
  - Q1. Can you please confirm the unit of measure on the bid form for Ferric Sulfate? Is it for pounds or should it say tons?

- **A1.** It is in tons. We typically purchase 6,000 tons annually.
- Q2. The Liquid Ferric Sulfate quantity states 6,000 pounds. I wanted to double-check on this and see if it is supposed to state 6,000 tons.
- **A2.** Yes, see the response to question 1.
- Q3. What is the typical load size per delivery of powdered activated carbon?
- A3. Typical delivery load size in 400 50 lb. bags.
- Q4. Are there any special delivery needs such as a lift gate or pallet jack for the powdered activated carbon?
- **A4.** We have a dock for offloading PAC at each facility, but the vendor will need to have a pallet jack.
- Q5. Can you please provide the current pricing and supplier of your 19.2% Aqueous Ammonia?
