

## **RESIDENTIAL WATER SERVICE – INSIDE CITY**

<u>AVAILABILITY</u> Available throughout the territory served by the Fayetteville Public Works Commission ("PWC"), inside the limits of the City of Fayetteville, in accordance with PWC's Service Regulations and Charges.

<u>APPLICABILITY</u> Applies to water supplied for residential purposes at a single point of delivery through a single meter.

<u>**CHARACTER OF SERVICE</u>** The volume of water flow and residual pressure at the point of delivery shall be in accordance with PWC's approved flow standards.</u>

**MONTHLY RATE** The monthly rate shall be the Usage Charge plus the Basic Facilities Charge plus the Backflow Prevention Assembly Inspection Charge, where applicable.

**BACKFLOW PREVENTION ASSEMBLY INSPECTION CHARGE** In situations where a split tap is done on the customer's side of the meter for the purpose of lawn and garden watering, swimming pool filling, etc., an additional monthly charge of \$3.65 shall be assessed for periodic inspection of the backflow prevention assembly device.

**<u>CONTRACT PERIOD</u>** The contract period shall be continuous from the date of connection through the date of disconnection.

**WATER SHORTAGE ORDINANCE** Should PWC's General Manager declare/proclaim a water shortage, this rate is subject to change by adding a 15% surcharge to usage over 5,000 gallons.

**<u>UTILITY LINE RELOCATION RIDER</u>** As specified in the Service Regulations and Charges, a monthly surcharge to recover utility line relocation due to expansions that are allocated to PWC.

Utility Line Relocation Rider - for Residential \$4.00

**<u>PAYMENTS</u>** All bills shall be paid in accordance with the terms of the Service Regulations and Charges.
