



LARGE USER SANITARY SEWER SERVICE

AVAILABILITY Available throughout the territory served by the Fayetteville Public Works Commission (“PWC”), in accordance with PWC’s Service Regulations and Charges.

APPLICABILITY Applies to Large Users sanitary sewer service where the customer is billed monthly for water service by PWC under Rate Schedule WSLU or discharges 1,000,000 gallons (minimum of three (3) months out of a rolling twelve (12) months to qualify for this rate) and where all wastewater is discharged into the sanitary sewer system at a single discharge point.

CHARACTER OF SERVICE Wastewater shall be collected and treated in accordance with the Sanitary Sewer Use Ordinance of the City of Fayetteville.

MONTHLY RATE The monthly rate shall be the sum of the Usage Charge, Basic Facilities Charge and the Sanitary Sewer Surcharge (where applicable).
