

Fayetteville Public Works Commission Rain Sensor Program Terms and Conditions

2025 Rain Sensor Program Rules

- Qualifying purchase must be new rain sensor. Resale rain sensors, new parts installed in existing
 product, or product that are leased, rebuilt, rented, received from insurance claims, received
 warranty, or won as a prize do not qualify.
- Application for qualifying rain sensor must be submitted within <u>forty-five (45) days</u> of purchase and installation.
- Qualifying rain sensor does not guarantee approval of bill credit. Bill credit is offered on a firstcome, first-served basis and is subject to availability of funds.
- Applicant's PWC account must be current, with active service, and non-delinquent (i.e. no past due balances) at the time the application is processed, or application will be denied. Should the past due balance be rectified within thirty (30) days of date on denial notification.
- Paid invoice/receipt must clearly identify the rain sensor and include date of purchase, purchase
 price, and manufacturer. Program application must be complete and include a copy of the
 purchase receipt.
- Applicant must submit all paperwork required of Program to be eligible for bill credit.
- PWC is not responsible for lost, damaged, late, illegible, misdirected or postage-due applications.
- Credit is issued as a bill credit to the PWC service account and may take up to ninety (90) days to process.
- PWC reserves the right to verify sales receipts and/or installations of rain sensor before issuing bill credit.
- Applicant shall agree to a possible post-installation audit by a PWC Conservationist.
- All terms, conditions, and rules of the Rain Sensor Programs are subject to change.
- Program eligibility is April 1, 2025 September 30, 2025.

Eligibility Requirements

- Applicant must be PWC residential or non-residential customer with active water or irrigation service in good standing
- Applicant must be homeowner and account holder of record where rain sensor is being installed
- Applicant must apply for bill credit within 45 days of purchase
- Bill credit may not exceed the total purchase price of the rain sensor (less taxes)
- Customer is eligible for one (1) rain sensor bill credit; not to exceed \$50.00
- Applicant must submit all paperwork required of this Program
- Applicant must agree to Terms and Conditions of this Program
