IV. GRAYS CREEK ELEMENTARY SCHOOLS WATER MAIN EXTENSION UPDATE Presented by: Misty Manning, Chief Operating Officer, Water Resources Allan Riddle, Water Resources Engineer III

Mr. Bryant presented Ms. Misty Manning, Chief Operating Officer, Water Resources and Mr. Allan Riddle to provide an update on the Grays Creek and Alderman Road Elementary Schools Water Main Extension.

Ms. Manning stated this project was part of an allocation of funding from the state legislature. We are full on in design. She stated Mr. Riddle is an Engineer III in our Water Resources Engineering Department. His team oversees our CIP projects, and he will provide a brief update and where we stand and our next steps.

Mr. Allan Riddle stated in his brief update, he will provide a project overview; the schedule; status and next steps.

Bringing a questioning attitude of what could go wrong and have we mitigated what could go wrong in our work planning and in our execution. Keeping our focus before, during and after work tasks are complete will help to ensure we keep each other safe as we work toward this journey of building a stronger safety culture here at PWC.

People

Our PWC team members continue to be our greatest asset. As such, our team members and their leaders continue to work together to ensure that the necessary knowledge, skills and abilities to perform work tasks today and in the future are there. We continue to refine job descriptions, roles and responsibilities to more effectively deliver on our commitment to delivering outstanding services



at a greater value to our customers on our way to be recognized as one of the best utilities in the United States.

Community Engagement/Customer Engagement

PWC will host the Power and Water Conservation Expo on March 28th at 121 Hay Street (Skyview). This free event is open to all community members and customers to see up close how PWC delivers upon its public power, water and wastewater mission and our local impact.

Running the Business

PWC Electric Time of Use (TOU) Rates will begin on April 1st. We urge customers to shift their electric consumption to after 6pm and before 3pm daily.

Our FY26 budget planning continues to be underway, and staff looks forward to bringing to the Commission within the next several months our future financial plan as we continue to deliver award winning, cost effective, reliable and safe, electric, water and wastewater services. Additionally, we continue to work with our federal delegation to obtain updates on the reviews of all our grant funding that are currently being frozen as the federal government goes through its process of reviewing all infrastructure funds.

Attached are two resolutions for Commission action at its April 9, 2025 meeting and below is a summary explaining the purpose of each.

- PWC2025.09 In March 2025, the North Carolina Department of Environmental Quality (DEQ) offered PWC \$500,000 from the IIJA DWSRF-EC funds for the PO Hoffer/Glenville Lake WTP GAC Facilities Design project. To accept the funding offer, PWC must adopt this resolution accepting the principal forgiveness loan in the form provided by DEQ. DEQ administers the funds and PWC will make periodic draws throughout the Project upon presenting supporting documentation of eligible payments.
- PWC2025.10 Resolution directing the filing of State Revolving Loan application for funding the Line 54" Outfall Projects, which are currently estimated at \$30,800,000. The application for said loan is due no later than April 30, 2025, and must include the original of this resolution. Details of the loan will be forthcoming in the award letter should PWC be awarded the loan and resolution accepting the offer will be presented to the Commission at that time.

Staff recommends that the Commission adopt attached (Resolution No. PWC2025.09) to accept the IIJA DWSRF-EC funds for the PO Hoffer/Glenville Lake WTP GAC Facilities Design project and adopt attached resolution (Resolution No. PWC2025.10) directing Staff to file State Revolving Loan Application for the Line 54" Outfall Projects.

RESOLUTION OF THE FAYETTEVILLE PUBLIC WORKS COMMISSION TO ACCEPT A STATE LOAN OFFER UNDER THE INFRASTRUCTURE INVESTMENT AND JOBS ACT OF 2021

WHEREAS, the Infrastructure Investment and Jobs Act (IIJA) of 2021 and North Carolina General Statute (NCGS) 159G have authorized the making of principal forgiveness loans to aid eligible, drinking water system owners in financing pre-construction activities and planning efforts associated with the removal of per- and polyfluoroalkyl substances (PFAS); and

WHEREAS, the North Carolina Department of Environmental Quality (NCDEQ) has offered a Drinking Water State Revolving Fund – Emerging Contaminants (DWSRF-EC) loan with principal forgiveness in the amount of \$500,000 for the PO Hoffer/ Glenville Lake WTP GAC Facilities Design project (Exhibit A); and

WHEREAS, the Fayetteville Public Works Commission (hereinafter, the "COMMISSION") intends to perform said project in accordance with the agreed scope of work; and

WHEREAS, the loan terms for PO Hoffer/Glenville Lake WTP GAC Facilities Design project are 100% principal forgiveness and 2% closing fee.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION THAT:

1. The COMMISSION does hereby accept the IIJA DWSRF-EC principal forgiveness loan offer of \$500,000 as presented in Exhibit A, contingent upon approval of the same by the City Council of the City of Fayetteville pursuant to Charter Section 6A.19.

2. The COMMISSION does hereby give assurance to NCDEQ that all items specified in the loan offer, Section II – Assurances will be adhered to.

3. Timothy L. Bryant, CEO/General Manager of the COMMISSION, and successors so titled, is hereby authorized and directed to furnish such information as the appropriate State agency may request in connection with such application or the project; to make the assurances as contained above; to execute the promissory note; and to execute such other documents as may be required in connection with the application.

4. The COMMISSION has substantially complied or will substantially comply with all Federal, State and local laws, rules, regulations, and ordinances applicable to the project and to Federal and State grants and loans pertaining thereto.

5. The COMMISSION requests that the City Council of the City of Fayetteville approve this loan pursuant to Charter Section 6A.19 by adopting a Resolution in the form attached hereto.
