3. Following are questions received about the solicitation and the SME's answers to the questions.

Q1. Please advise if extensions will be consider?

A1. Yes, we'll extend the bid opening until August 19, 2025.

Q2. Would you please also confirm the total qty being requested? I see quantities beside four of the poles only; are the others a qty of 1?

A2. We are only soliciting prices for four the four line items in the Attachment B: Bid Pricing Form.

Q3. The grant was for 480 poles but the quantity on the RFQ appears to be 375 poles. Can you please clarify?

A3. Quantities listed are estimates only based on anticipated project needs. PWC does not guarantee a minimum or maximum quantity to be purchased. The bidder represents and warrants that it has the capacity and expertise necessary to manufacture and deliver the initially estimated quantity of galvanized steel poles and accessories, as well as any additional volume of up to twenty percent (20%) beyond the initial estimate.

Q4. Would pole deliveries need to be staggered? I'm assuming this is a multi-year project and you wouldn't want delivery all at once.

A4. Yes, deliveries will be staggered. Yes, the project is multi-year, and releases will be coordinated via POs from the PWC Warehouse.

- Q5.** Is a bid bond required?
A5. No, a bid bond is not required.
- Q6.** Project Delivery and Location?
A6. Delivery will be to the PWC Warehouse, 1097 Public Works Drive, Fayetteville, NC, 28301.
- Q7.** Is the attached the only document available? Are there any drawings?
A7. Yes, the material specifications included in the IFB are the only documents.
- Q8.** Are there loads and pole classes available?
A8. The pole strength requirements are in the specifications.
- Q9.** BAK and LCA files available?
A9. BAK and LCA files are not being provided to the supplier.
- Q10.** Can you ask if there is a drawing for the framing? Are we to include any type of climb?
A10. Drawings are to be submitted from the manufacturer to PWC Engineering for approval after the award. There are no holes to be pre-drilled for framing.
- Q11.** I understand bids are due by 2:30pm on August 12th however Meyer Utility Structures is requesting an extension to 8/19. Is that possible?
A11. Yes, we'll extend the bid opening until August 19, 2025.
- Q12.** Can you also get clarification if Attachment C,D & E are required at time of bid since it says 'Contract' on it? If they need to be filled out, can you get clarification on Attachment C it states" acknowledgment of above signatures must be notarized using from on following page" but there is no following notary page included.
A12. Yes, these are required at the time of the IFB submittal and will become part of the Sale of Goods Agreement to the successful bidder.
