AVAILABILITY

Available throughout the territory served by the Fayetteville Public Works Commission (“PWC”) in accordance with PWC’s established Service Regulations and Charges.

APPLICABILITY

Applicable to electric service used for nonresidential uses where the lower of contract or metered demand is less than or equal to 30 kW; provided, however, if demand exceeds 35 kW at least twice in any twelve (12) consecutive month period or if demand exceeds 50 kW at least once in any twelve (12) consecutive month period, PWC may move Customer to Medium Power Service. Metered demand, for purposes of determining the applicability of this rate schedule, shall be computed on the basis of the highest fifteen (15) minute aggregate demand measured each month by the billing meter installed by PWC at the point of delivery for the Customer and the non-billing meter installed by PWC on the Customer’s side of the point of delivery to measure the output of all customer-owned generation, including but not limited to peak shaving generation and generation from qualifying facilities, but excluding generation used solely for emergencies in compliance with the operational limitations and emissions limitations established by the applicable North Carolina Department of Environmental Quality air permit. In accordance with PWC’s Service Regulations and Charges, PWC may change the Customer’s rate classification.

CHARACTER OF SERVICE

Service shall be single-phase or three-phase, sixty hertz alternating current at PWC’s standard available voltages. Service shall be provided at a single point of delivery through one meter.

MONTHLY RATE

- I. Basic Facilities Charge*
 - a. Single-Phase Service Charge: \$40.00
 - b. Three-Phase Service Charge: \$58.00
- II. Energy Charge
 - a. All kWh On-Peak Hours: \$0.16450 per kWh
 - b. All kWh Off-Peak Hours: \$0.10885 per kWh

DEFINITION OF PEAK PERIODS

Peak period is defined as daily.

- I. On-Peak Hours
 - a. Summer (April – October): 3:00 PM to 6:00 PM
 - b. Non-Summer (November – March): 6:00 AM to 9:00 AM
- II. Off-Peak Hours: All hours other than On-Peak Hours

POWER SUPPLY ADJUSTMENT (PSA)

All stated rates are subject to a monthly power supply adjustment (PSA).

SPECIAL FACILITIES CHARGES

As specified in the Service Regulations and Charges, a monthly surcharge may be assessed for special facilities provided by PWC.

*An additional \$4.00 Community Street Lighting charge applies to each meter billed on this rate schedule.
